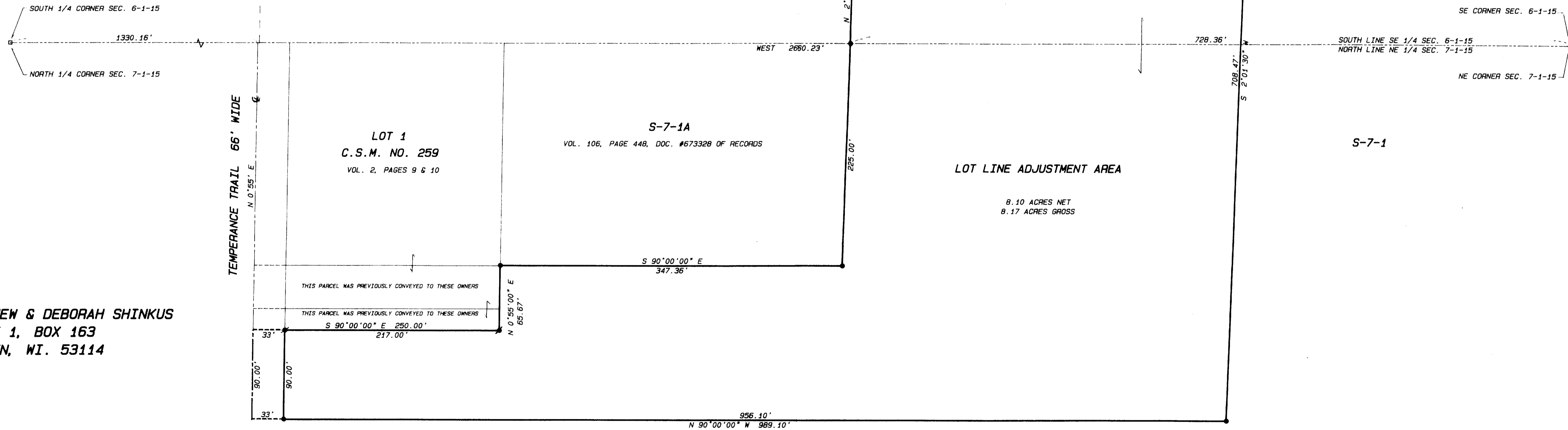
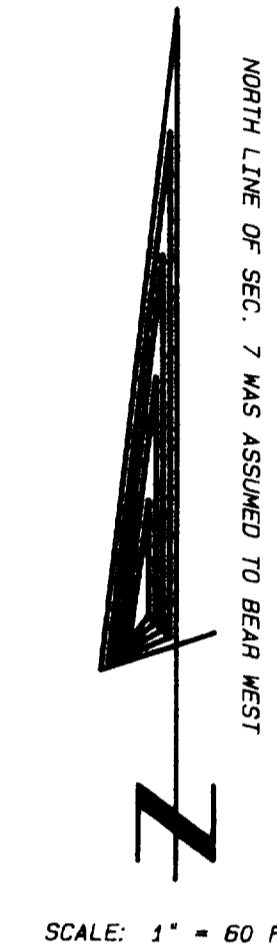
LEGAL DESCRIPTION FOR LOT LINE ADJUSTMENT:

A PARCEL OF LAND LOCATED IN THE NORTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 7 AND IN THE SOUTHEAST 1/4 OF SECTION 7 AND IN THE SOUTHEAST 1/4 OF SECTION 6, TOWN 1 NORTH, RANGE 15 EAST, TOWN OF SHARON, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTHEAST CORNER OF SAID SECTION 7; THENCE WEST ALONG THE NORTH LINE OF SAID SECTION 7, 728.36 FEET TO THE POINT OF BEGINNING; THENCE N 2°01'30" E 327.72 FEET; THENCE S 90°00'00" E 394.76; THENCE S 2°01'30" N 708.47 FEET; THENCE N 90°00'00" N 989.10 TO A POINT IN THE CENTERLINE OF TEMPERANCE TRAIL ROAD; THENCE N 0°55'00" E ALONG THE CENTERLINE OF TEMPERANCE TRAIL ROAD 90.00 FEET; THENCE S 90°00'00" E ALONG THE SOUTH LINE OF A PREVIOUS LOT LINE ADJUSTMENT 250.00 FEET; THENCE N 0°55'00" E TO A POINT ON THE EAST LINE OF C.S.M. NO. 259, 65.67 FEET; THENCE S 90°00'00" E 347.36 FEET; THENCE N 2°01'30" E 225.00 FEET TO THE POINT OF BEGINNING. 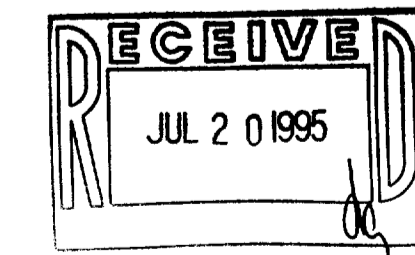

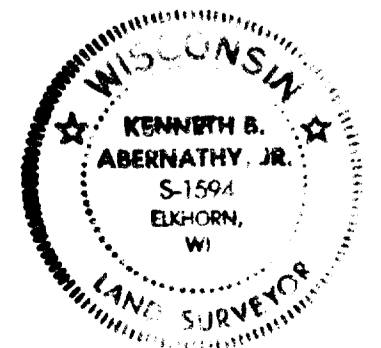
