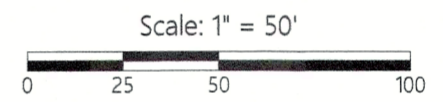


PLAT OF SURVEY

AND ALSO A PARCEL OF LAND LOCATED IN THE NORTHEAST 1/4 AND THE SOUTHEAST 1/4 OF SECTION 25, T. 1 N., R. 15 E., WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTH 1/4 CORNER OF SAID SECTION 25; THENCE N 0°59'05" W 1859.55 FEET ALONG THE WEST LINE OF SAID SOUTHEAST 1/4 TO THE PLACE OF BEGINNING; THENCE CONTINUE N 0°59'05" W 228.00 FEET ALONG SAID WEST LINE TO THE SOUTHWEST CORNER OF CERTIFIED SURVEY MAP NO. 2376; THENCE N 89°32'55" E 455.00 FEET TO THE SOUTHEAST CORNER OF SAID CERTIFIED SURVEY; THENCE N 0°59'05" W 478.66 FEET TO THE NORTHEAST CORNER OF SAID CERTIFIED SURVEY; THENCE S 89°32'55" W 455.00 FEET TO THE WEST LINE OF SAID SOUTHEAST 1/4 AND THE NORTHWEST CORNER OF SAID CERTIFIED SURVEY; THENCE N 0°59'05" W 84.40 FEET TO THE CENTER OF SAID SECTION 25; THENCE N 0°59'07" W 145.60 FEET ALONG THE WEST LINE OF SAID NORTHEAST 1/4 OF SAID SECTION 25; THENCE N 89°32'55" E 465 FEET; THENCE S 0°59'05" E 936.66 FEET; THENCE S 89°32'55" W 465.00 FEET TO THE WEST LINE OF SAID SOUTHEAST 1/4 OF SAID SECTION 25 AND THE PLACE OF BEGINNING, CONTAINING 5.00 ACRES OF LAND.

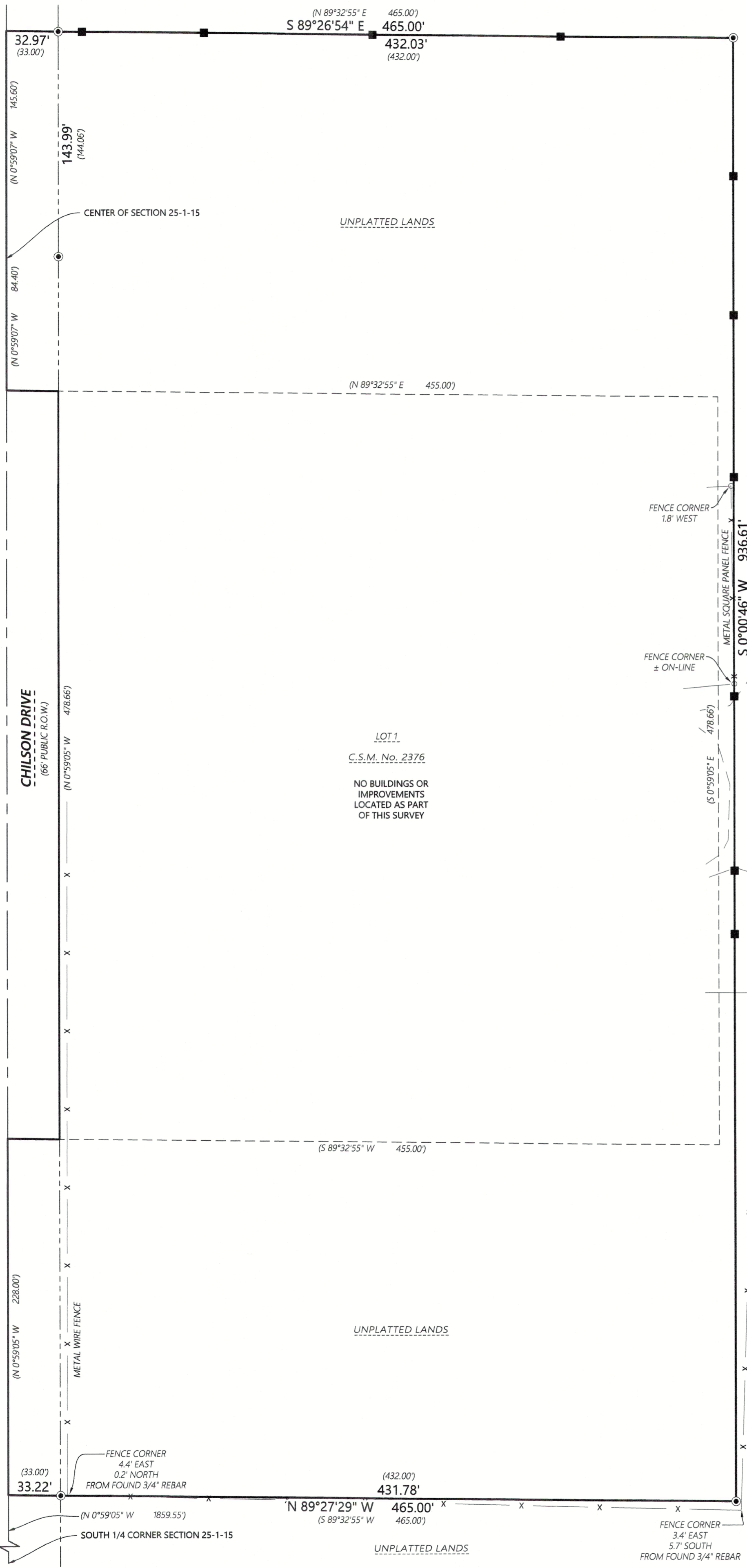

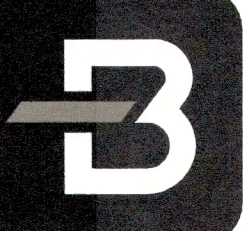
