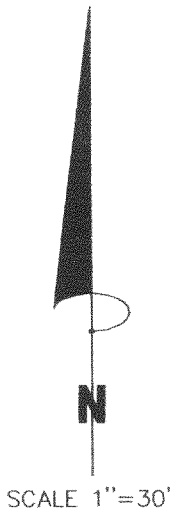
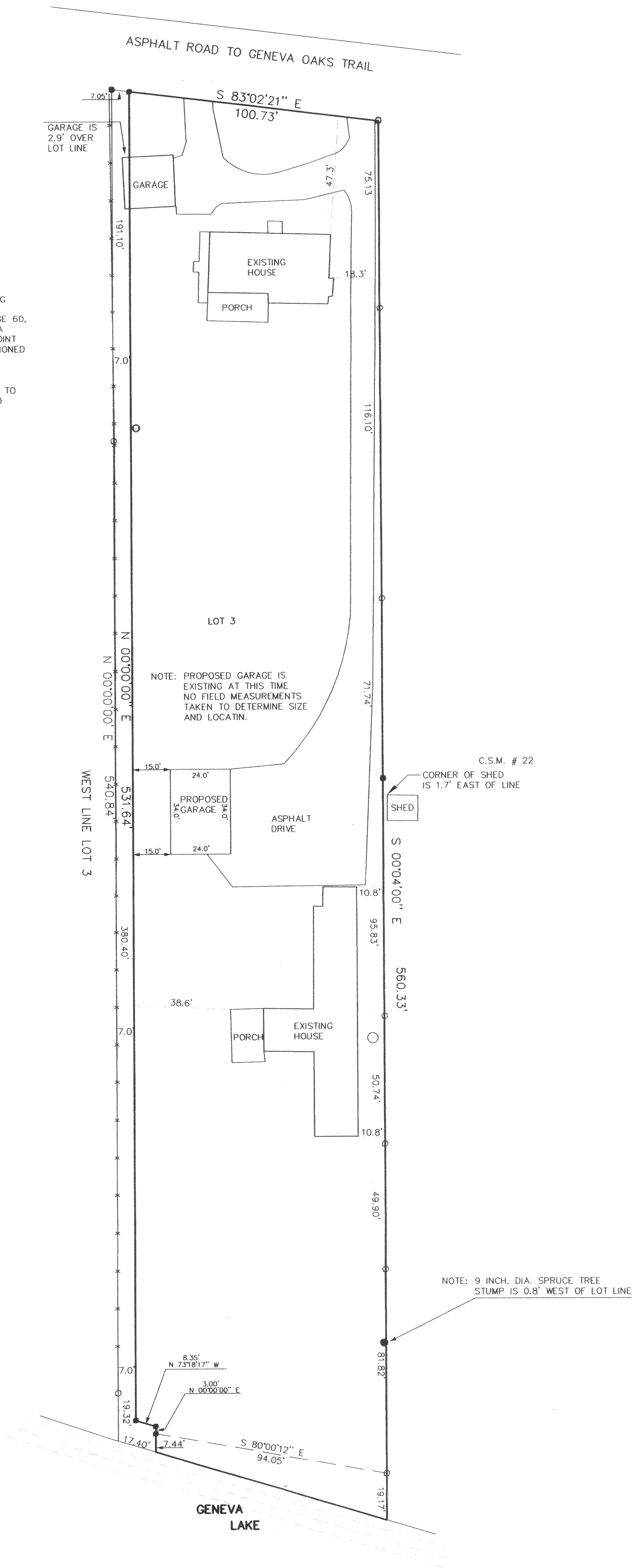


PLAT OF SURVEY

CHAPIN'S SUBDIVISION, ACCORDING TO THE PLAT THEREOF RECORDED IN THE OFFICE OF REGISTER OF DEEDS IN AND FOR WALWORTH COUNTY, WISCONSIN IN VOLUME 7 OF PLATS AT PAGE 60, THENCE SOUTH ON THE WEST LINE OF SAID LOT 3 TO THE SHORE OF GENEVA LAKE, THENCE SOUTHEASTERLY ALONG THE SHORE OF GENEVA LAKE TO A POINT LOCATED 15.0' FEET EAST OF, MEASURED AT RIGHT ANGLES, THE AFOREMENTIONED WEST LINE OF LOT 3, THENCE NORTH PARALLEL WITH, AND 15.0' EAST OF, THE WEST LINE OF SAID LOT 3, 10.0' THENCE NORTHWESTERLY PARALLEL TO THE SHORE OF GENEVA LAKE TO A POINT 7.0' EAST OF THE WEST LINE OF SAID LOT 3, THENCE NORTH PARALLEL TO THE WEST LINE OF SAID LOT 3 TO THE NORTH LINE OF SAID LOT 3, THENCE WEST ALONG SAID NORTH LINE 7.0 FEET TO THE PLACE OF BEGINNING.

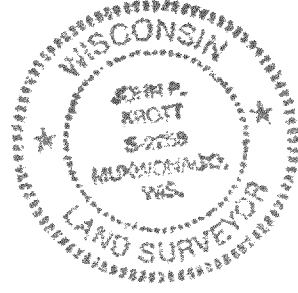
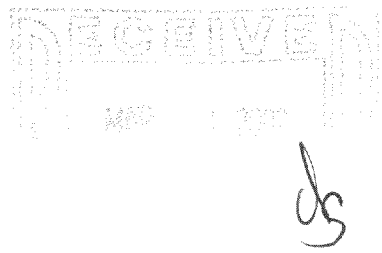
