A PARCEL OF LAND BEING A PART OF LOT 17 OF ELGIN CLUB, A SUBDIVISION LOCATED IN SECTION 4, TOWN 1 NORTH, RANGE 17 EAST, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:
COMMENCING AT A CONCRETE MONUMENT MARKING THE NORTHWEST CORNER OF LOT 17; THENCE S 87 DEG 50 1/2 MIN E, 74.72 FEET TO THE POINT OF BEGINNING; THEN CONTINUE S 87 DEG 50 1/2 MIN E, 2.0 FEET TO A CONCRETE MONUMENT; THENCE N 61 DEG 04 MIN E, 84.22 FEET TO AN IRON REBAR STAKE; THENCE S 00 DEG 02 1/4 MIN E, 178.01 FEET TO AN IRON REBAR STAKE AND THE BEGINNING OF A MEANDER LINE; THENCE CONTINUE S 00 DEG 02 1/4 MIN E, 35.59 FEET MORE OR LESS TO A POINT AT THE SHORELINE OF LAKE GENEVA; THENCE ALONG SAID SHORELINE 92 FEET MORE OR LESS TO A POINT; THENCE N 00 DEG 02 1/4 E, 58.34 FEET MORE OR LESS TO AN IRON REBAR STAKE ON THE END OF THE AFORESAID MEANDER LINE; THENCE CONTINUE N 00 DEG 02 1/4 E, 144.05 FEET TO THE POINT OF BEGINNING, CONTAINING 15,856 SQUARE FEET OF LAND (0.36 AC.)
