Dear Sir, We surveyed your lot number 53 in the Lake Geneva HIGHLANDS SUBDIVISION on the South side of Lake Geneva and found everything as you told us and as shown on the plat we got from Trinke. That yellow house you mentioned is on lot 39 fronting on OAKDALE ROAD. Has a concrete wall all around it. We checked that lot all around. That lot is cornerwise to your lot that is, the N.W. corner of that lot is your Southeast Cor. and is O.K. His East line is two feet over in Oakdale Road but that does not matter. The North wall of his lot bulges in the middle quite a little but that does not in any way affect your lot. Your lot is 50 feet North and South and 100ft. East and West and is O.K. in every respect. We set Iron and wood stakes at the N.W.S.W. and N.E. Cors of your lot and the S.E. Cor. of your lot is the N.W. Cor. of his wall.

There is a large oak tree near the front of your lot on the South line, the ~~North~~ side of which comes just to your South line. I know it is there for I fell and struck my head against it. The South side of that tree is the South line of your lot, so everything is clear. Our bill for the entire work and plat is Five Dollars.
