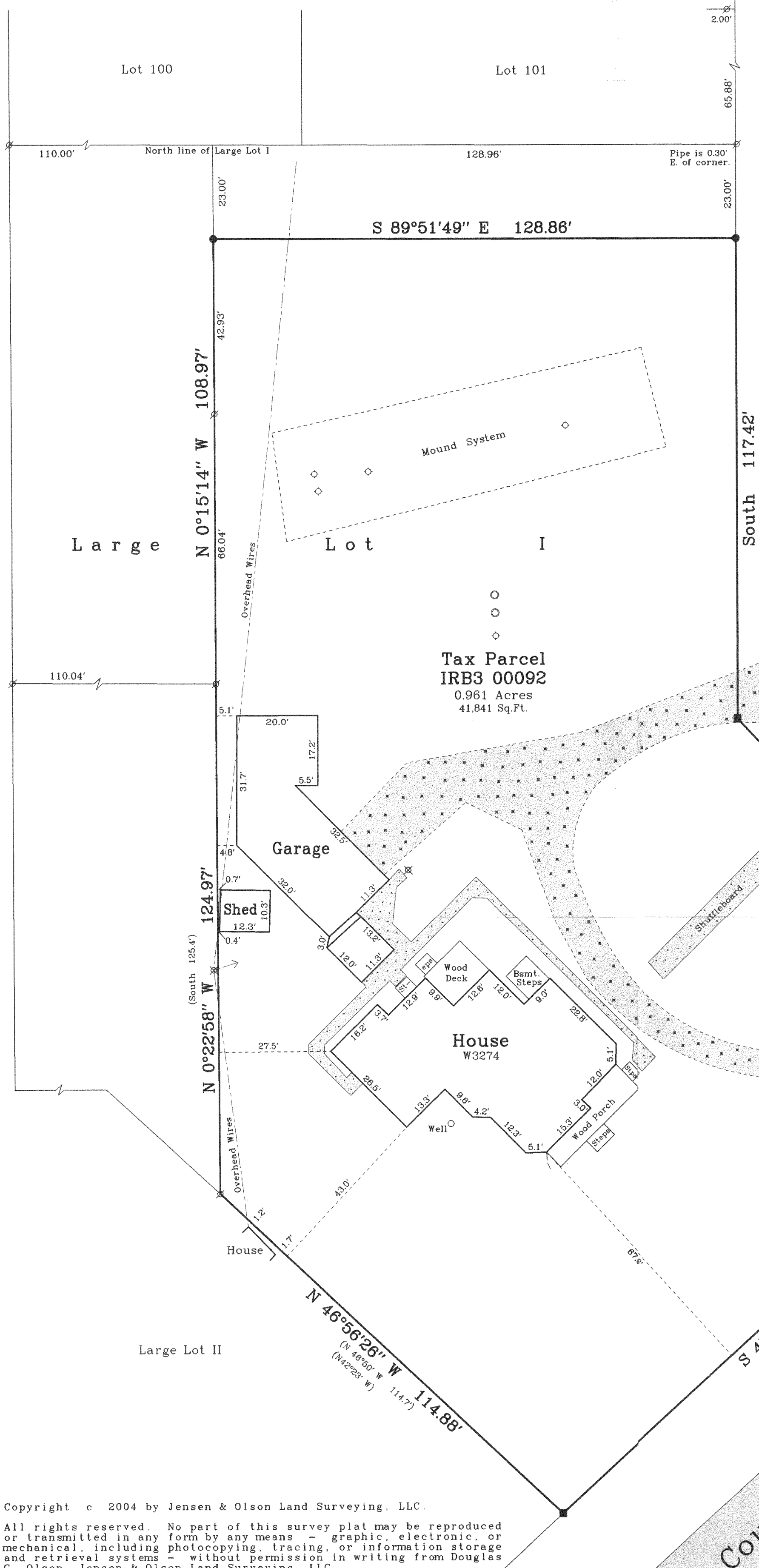


Plat of Survey

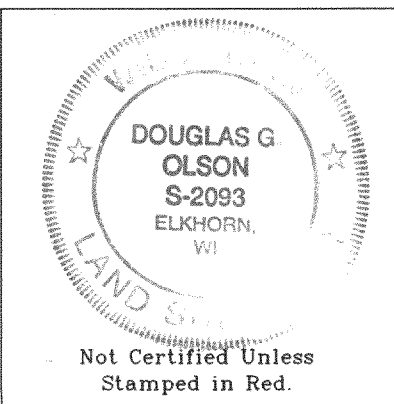
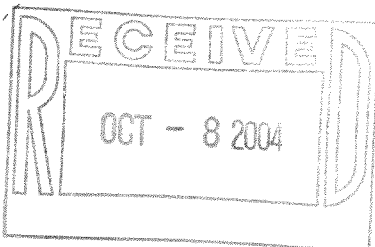
