PROPOSED BUILDING SET BACK FROM SHORE

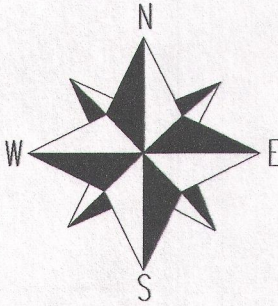

EXISTING PLATTED BUILDING SETBACK LINE

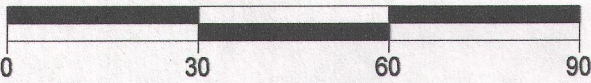
