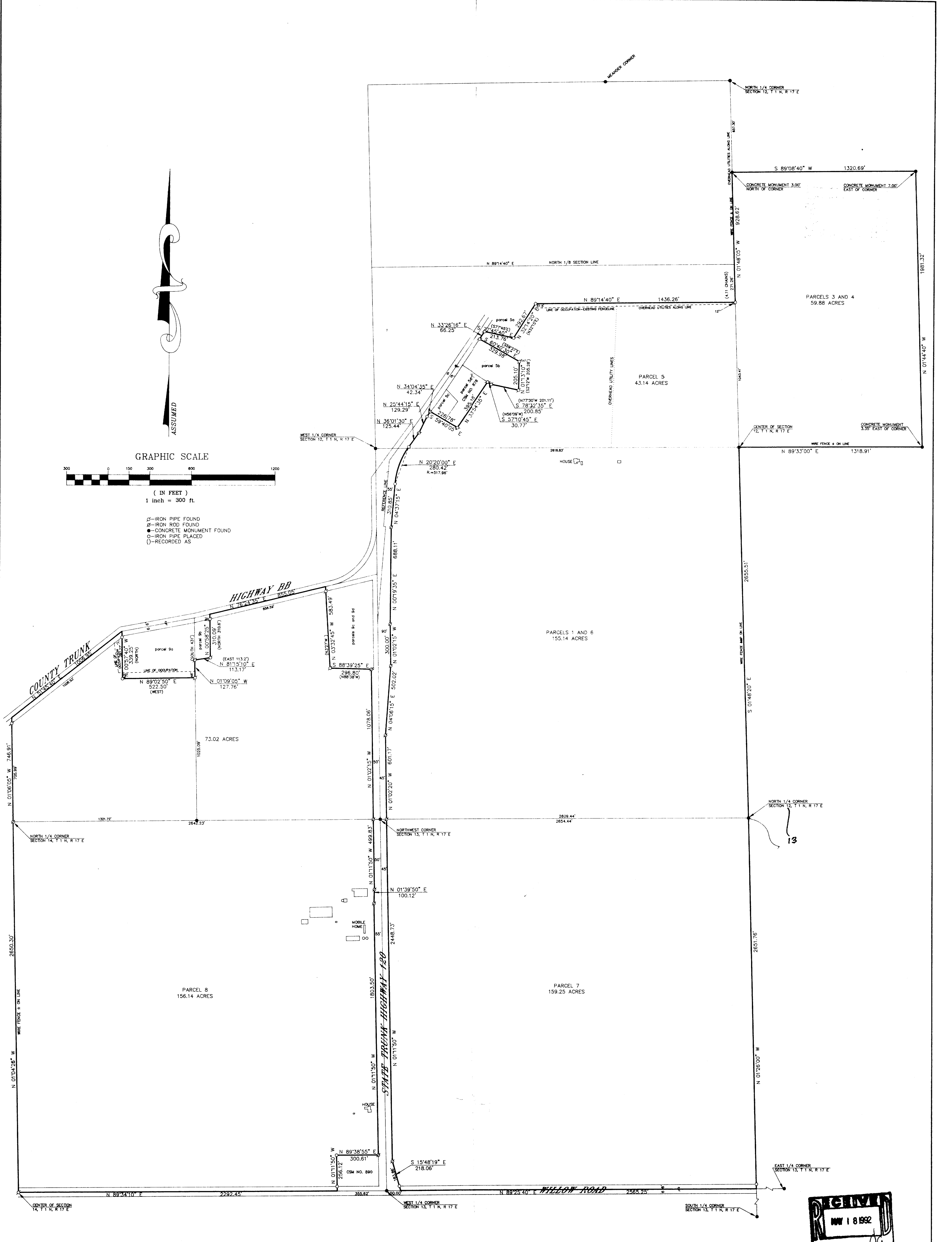


- ⊖—IRON PIPE FOUND

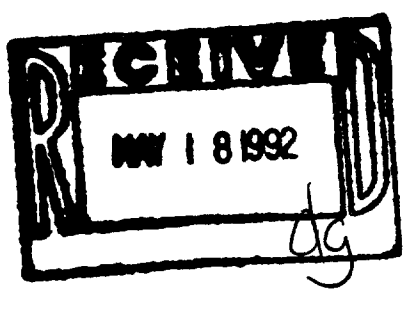
