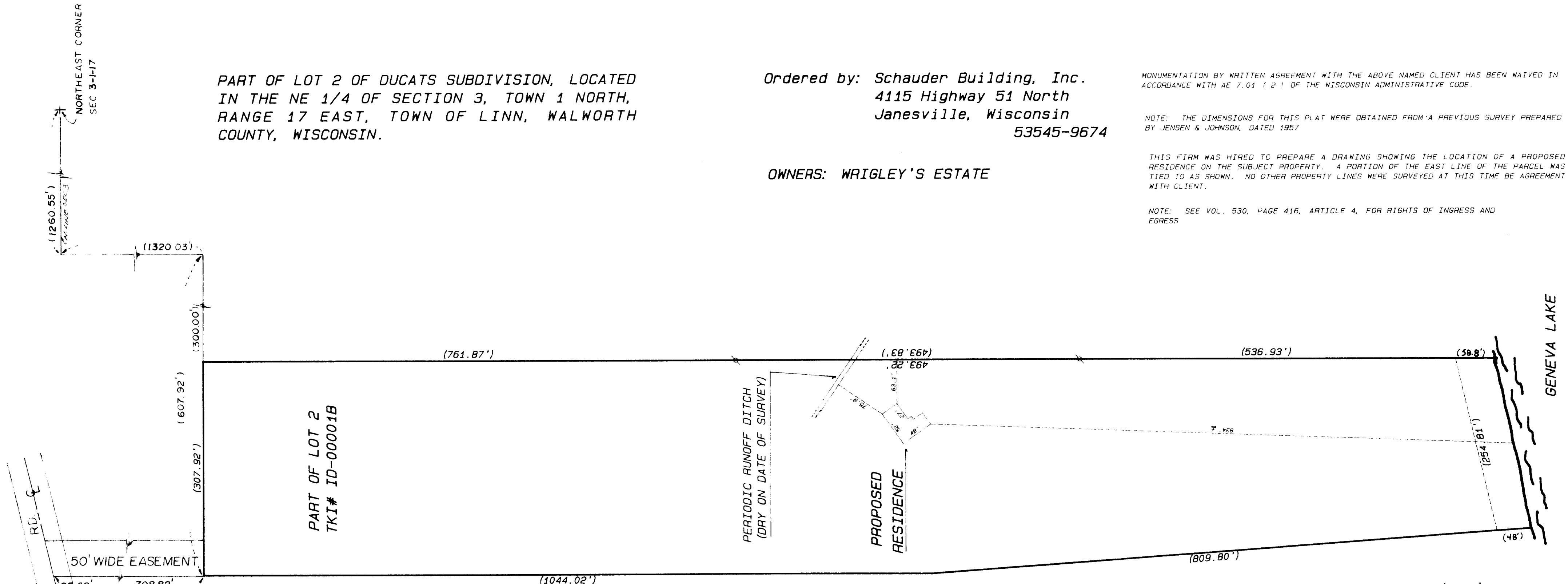

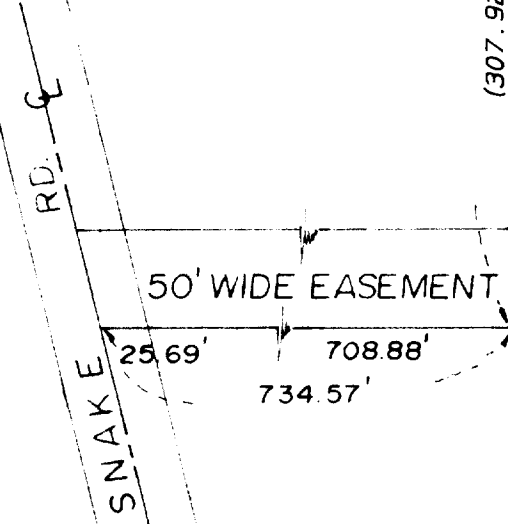

A 50 FOOT WIDE EASEMENT FOR INGRESS AND EGRESS LOCATED IN THE NE 1/4 OF SECTION 3, TOWN 1 NORTH, RANGE 17 EAST, WALWORTH COUNTY, WISCONSIN; THE WESTERLY LINE OF SAID EASEMENT IS DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTHEAST CORNER OF SAID SECTION 3; THENCE WESTERLY ALONG THE NORTH LINE OF SAID SECTION 3, 1260.55 FEET; THENCE SOUTHERLY 1320.03 FEET; THENCE WESTERLY 607.92 FEET TO THE NORTHWEST CORNER OF TAX KEY PARCEL NUMBER ID-00001B AND THE POINT OF BEGINNING OF THE WESTERLY LINE OF SAID EASEMENT; THENCE NORTHERLY 734.57 FEET TO A POINT IN THE CENTERLINE OF SNAKE ROAD AND THE POINT OF TERMINATION OF SAID WESTERLY LINE OF SAID 50 FOOT WIDE EASEMENT.

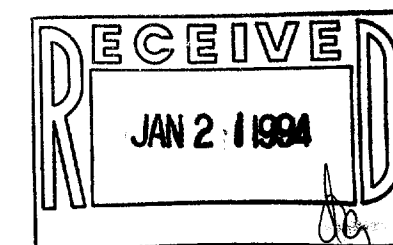
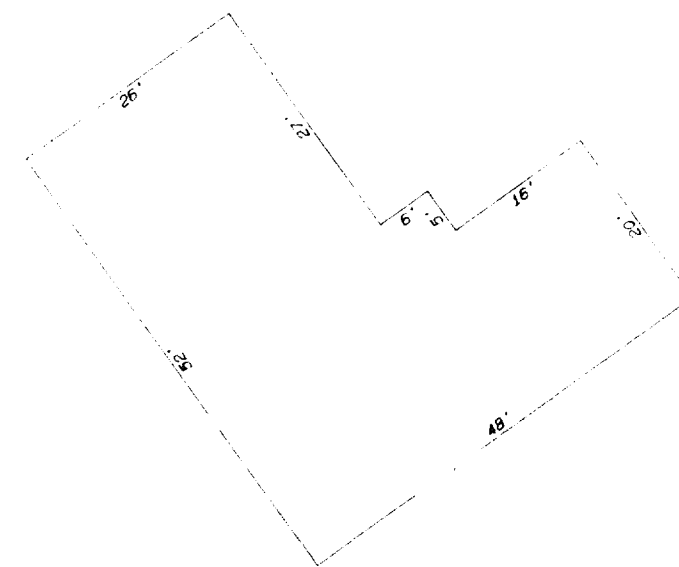
