


PLAT OF SURVEY OF



ALSO, A PART OF LOT 7, BLOCK 1 OF WOODDALE ADDITION, A SUBDIVISION IN SECTION 9, T 1 N, R 17 E, TOWN OF LINN, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: BEGINNING AT THE SE CORNER OF LOT 7, BLOCK 1, OF WOODDALE ADDITION AFORESAID, THENCE IN A NW'LY DIRECTION ALONG THE BOUNDARY LINE BETWEEN LOTS 6 AND 7, BLOCK 1 AFORESAID, TO THE SHORE OF GENEVA LAKE AT LOW WATER MARK 35 FEET TO A POINT; THENCE STRAIGHT IN A SE'LY DIRECTION TO A POINT IN THE SOUTH LINE OF LOT 7 AFORESAID WHICH IS 28 FEET IN A NE'LY DIRECTION FROM THE SW CORNER OF SAID LOT; THENCE IN A SW'LY DIRECTION ALONG THE SOUTHERLY BOUNDARY LINE OF SAID LOT 28 FEET TO THE SOUTHERLY CORNER OF LOT 7, BLOCK 1 AFORESAID AND THE PLACE OF BEGINNING.
