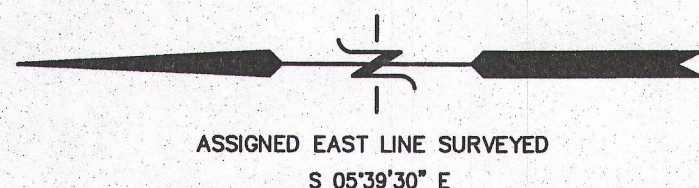
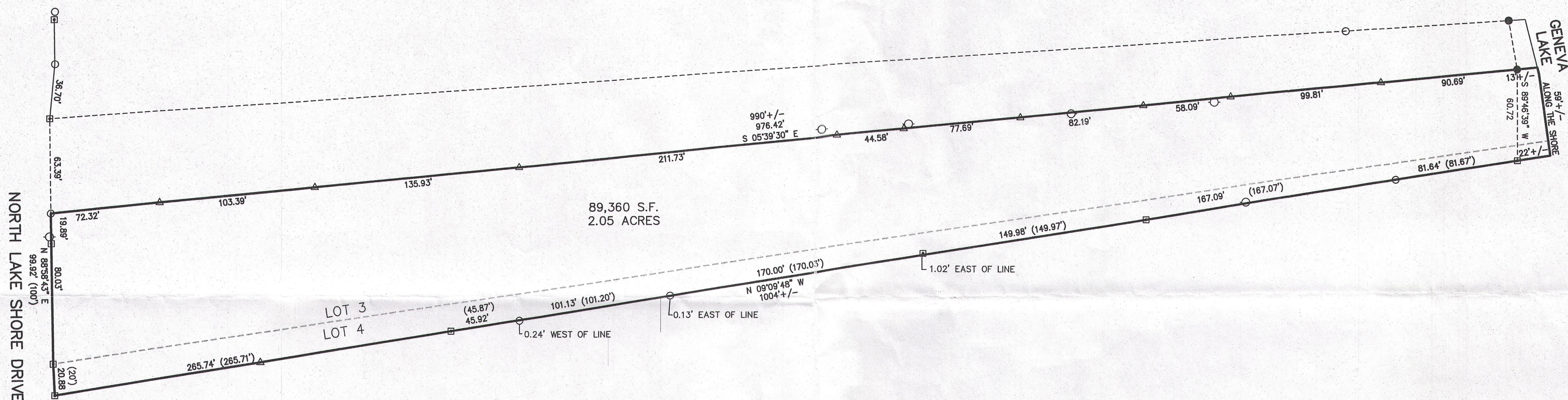




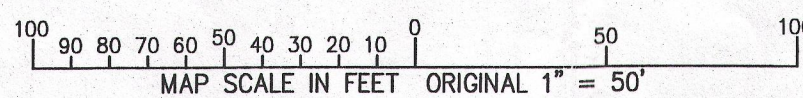
PLAT OF SURVEY

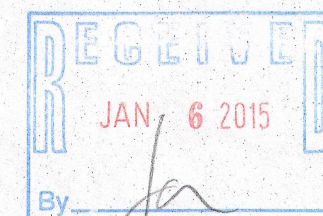
