ALSO a parcel of land being part of Lot 2, Certified Survey Map No. 16, as recorded in Volume 1, page 16, Certified Surveys, Walworth County Register of Deeds Office and described as follows, to-wit: Beginning at the Northwest corner of said Lot 2; thence North 89°40' East 375.00 feet; thence South 58°01' West 19.06 feet; thence South 89°40' West 358.81 feet; thence North 00°11' West 10.00 feet to the place of beginning. All lying and being in the Town of Linn, Walworth County, Wisconsin.

Certified Survey Map No. 16 was surveyed by Harold H. Kolb and dated October 18, 1965. The survey markers from this Certified Survey Map have been located and verified and most check fairly well with the record measurements. It appears that an error was made when the 2 pipe on the South line of Lot 1 were set. It appears a 1° angle error was made when measuring 97.00' west to point "A" from the pipe on the South line of Lot 1 at the R.O.W. of Snake Road as shown. It appears that the correct angle was then used (which resulted in a 1° bearing error) on the next 184.56' line toward point "B". Apparently the "closing" angle & distance to the West were not measured as a check. A Plat of Survey was prepared by Harold H. Kolb dated April 18, 1968 to convey a 10' wide atrip from Lot 2 to Lot 1 and 2 more check. A Plat of Survey was prepared by Harold H. Kolb dated April 18, 1968 to convey a 10' wide atrip from Lot 2 to Lot 1 and 2 more survey markers were set. A Plat of Survey was prepared by Harold H. Kolb dated September 6, 1969 of the remainder of Lot 2. This survey confirms the 79' distance from point "B" to point "C" across Lot 2 as it is currently monumented today. Based upon the location of the driveway just North of the pipe at point "A" and the graded slope just North of the concrete monument at point "B" it appears that the line as monumented fits well with evidence of "occupation". A Plat of Survey of Lot 2 was prepared by David F. Abell on June 29, 1999. On this survey the pipe at point "A" was accepted and the concrete monument at point "B" was called off. Using this method the distance from point "B" to point "C" is 84.12. A Permit Map of part of Lot 2 was prepared by Peter S. Gordon on April 27, 2012. On this map both the pipe at point "A" and the concrete monument at point "B" were called off. The iron pipe at point "A" and the concrete monument at point "B" appear to be in the location they were placed by Harold H. Kolb in 1965 and 1969, fit well with existing occupation and have been accepted as the property corners on this survey. and have been accepted as the property corners on this survey.
