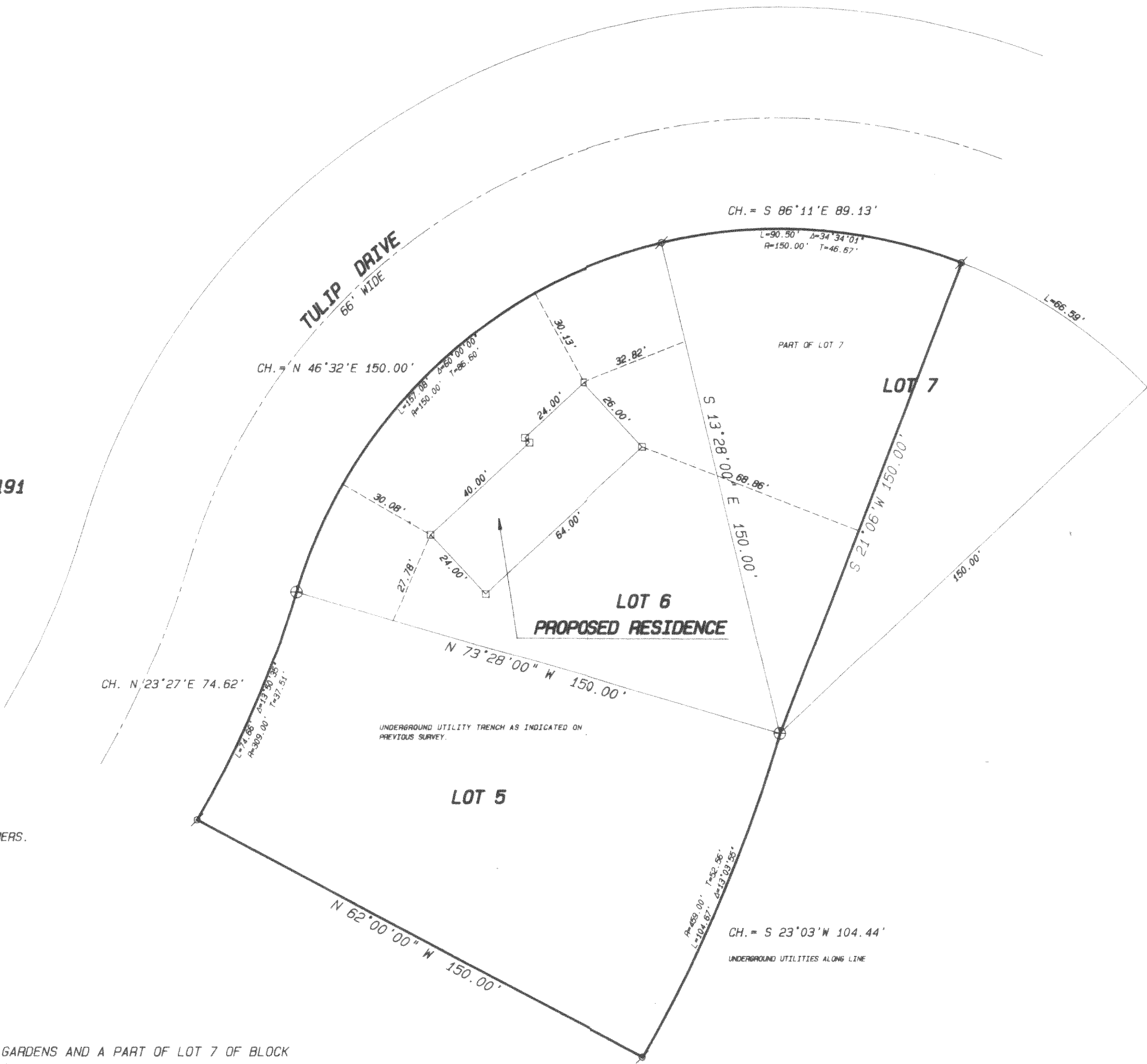


PLAT OF SURVEY

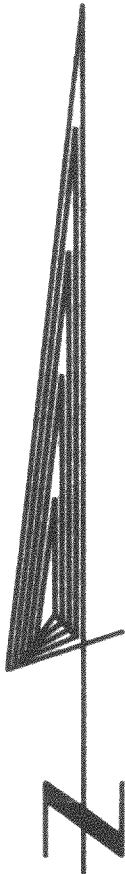

LEGAL DESCRIPTION:

LOTS 5 & 6, BLOCK 4 OF ROSE NIPPERSINK GARDENS AND A PART OF LOT 7 OF BLOCK 4 OF ROSE NIPPERSINK GARDENS MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGIN AT A CONCRETE MONUMENT AT THE MOST SOUTHERLY CORNER OF SAID LOT 7; THENCE N 13°28' W 150.00 FEET ALONG THE LINE BETWEEN LOTS 6 & 7, TO THE SOUTHERLY LINE OF ROAD; THENCE SOUTHEASTERLY 90.50 FEET ALONG THE ARC OF A CURVE CONVEX NORTHERLY AND HAVING A RADIUS OF 150.00 FEET AND A CHORD OF 89.13 FEET WHICH BEARS S 86°11' E; THENCE S 21°06' W 150.00 FEET TO THE PLACE OF BEGINNING. SAID LAND IS LOCATED IN SECTION 24, TOWN 1 NORTH, RANGE 18 EAST OF THE 4th P.M.M TOWNSHIP OF BLOOMFIELD, COUNTY OF WALWORTH, STATE OF WISCONSIN.

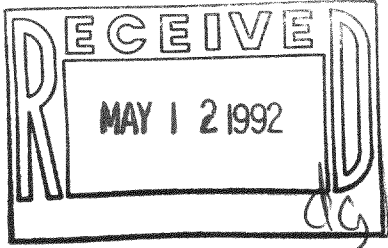
THIS SURVEY RETRACES A PREVIOUS SURVEY BY JOHN DEGEN DATED JANUARY 10, 1980.

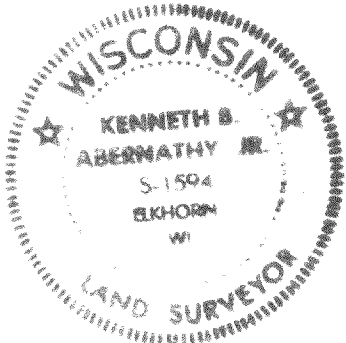
