

Parcel II: a parcel of land located in the Northeast Quarter of Section 15, Township 1 North, Range 18 East of the 4th Principal Meridian in Walworth County, Wisconsin, described as follows, to-wit: Commencing at the most westerly corner of Lot 6655 of Pell Lake Subdivision, which subdivision is recorded on Page 165 of Volume 7 of Plats at the Register of Deeds Office in and for said Walworth County; thence South 48 degrees 45 minutes West along the northwesterly end of Crocus Road, 35 feet to an iron stake on the northeasterly line of Lot 6656 of said subdivision; thence North 41 degrees 15 minutes West 90 feet to the northwest(recorded as northeast) corner of said Lot 6656; thence North 66 degrees 10 minutes East 142.97 feet to the most northerly corner of said Lot 6655; thence South 23 degrees 49 minutes West along the northwesterly line of said Lot 6655, 112.00 feet to the place of beginning.

Parcel III: that part of Crocus Road in the Pell Lake Subdivision, according to a plat of survey in the Northeast Quarter of Section 15, Township 1 North, Range 18 East of the 4th Principal Meridian, Walworth County, Wisconsin, described as follows: Commencing at the southeast corner of Lot 6652; thence southerly across Crocus Road to the northeast corner of Lot 6656; thence westerly along Crocus Road 60 feet; thence northerly across Crocus Road to the southwest corner of Lot 6655; thence easterly 60 feet along Crocus Road to the place of beginning.
