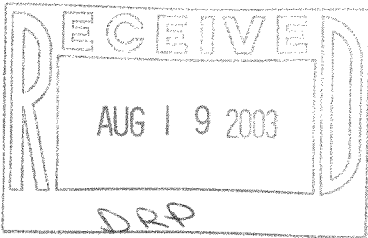

LEGAL DESCRIPTION FOR PARCEL 1

Part of Lot 1472 and all of Lots 1473 – 1475 of Block 32 of Pell Lake Subdivision, located in Town 1 North, Range 18 East, Walworth County, Wisconsin, described as follows; Commence at the Northwest Corner of said Block 32; thence S 2°30'E along the easterly line of Beech Road, 225.32 feet to a found iron pipe which marks the southwest corner of said Lot 1475; thence N 2°30'W along said road line 70.00 feet; thence N 87°29'37"E 140.20 feet; thence S 15°06'07"E 71.68 feet to a found iron pipe which marks the southeast corner of said Lot 1475; thence S 87°28'37"W along the southerly line of said Lot 155.84 feet to the point of beginning. Said parcel contains 10,229 square feet of land more or less.

LEGAL DESCRIPTION FOR PARCEL 2

Parts of Lots 1468 and 1472 and all of Lots 1469 – 1471 of Block 32 of Pell Lake Subdivision, located in Town 1 North, Range 18 East, Walworth County, Wisconsin, described as follows; Commence at the Northwest Corner of said Block 32; thence S 2°30'E along the easterly line of Beech Road, 79.32 feet to the point of beginning; thence N 87°30'52"E 123.22 feet; thence S 15°06'07"E 77.83 feet, thence S 87°29'37"W 140.20 feet to a point in the easterly line of Beech Road; thence N 2°30'W 76.00 feet along said road line to the point of beginning. Said parcel contains 10,007 square feet of land more or less.

LEGAL DESCRIPTION FOR PARCEL 3

Part of Lot 1468 and all of Lots 1462 – 1467 of Block 32 of Pell Lake Subdivision, located in Town 1 North, Range 18 East, Walworth County, Wisconsin, described as follows; Begin at the Northwest Corner of said Block 32; thence N 75°12'E along the southerly line of Grove Road 102.94 feet to the northeast corner of said Lot 1462 and a found iron pipe; thence S 15°06'07"E 103.79 feet; thence S 87°30'52"W 123.22 feet to a point in the easterly line of Beech Road; thence N 2°30'W 79.32 feet to the point of beginning. Said parcel contains 10,359 square feet of land more or less.

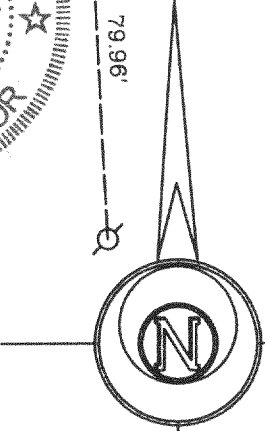
THE WEST LINE OF BLOCK 32
