

PLAT OF SURVEY

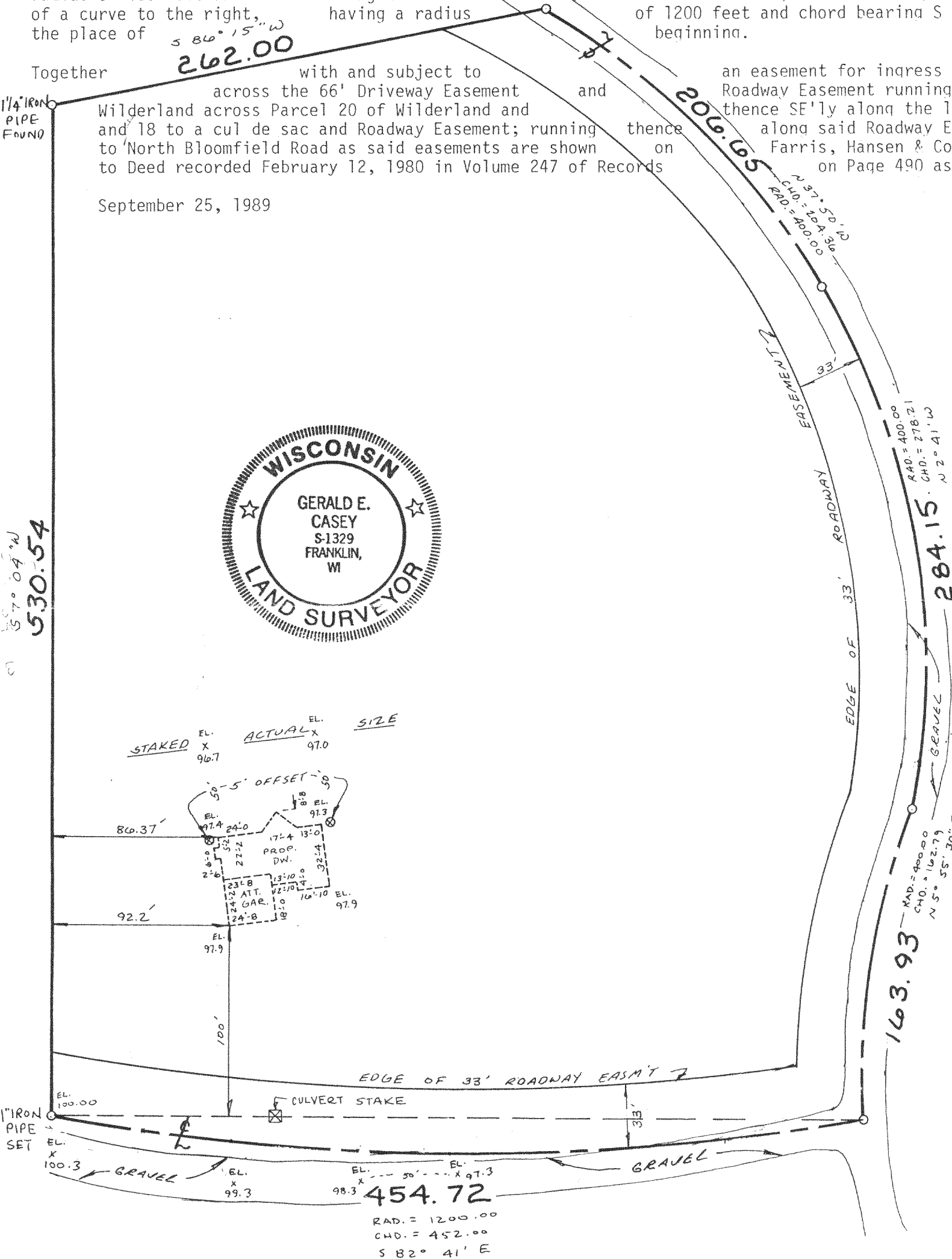
LOCATION: North Bloomfield Road, Walworth, Wisconsin

LEGAL DESCRIPTION: Parcel 7 in Wilderland Subdivision, an unrecorded subdivision located in part of the NW 1/4 of the SE 1/4 and part of the SW 1/4 of the SE 1/4 of Section 5, T1N, R18E, Walworth County, Wisconsin, being more particularly described as follows: Commencing at the SW corner of Lot 1 of Certified Survey Map No. 976 as recorded in Volume 4, page 239 of Certified Survey Maps, Walworth County; thence S 10° 48' East 172.00 feet; thence S 3° 54' 30" East 452.85 feet; thence S 7° 04' West 45.50 feet to the place of beginning; thence continue S 7° 04' West 530.54 feet; thence S 86° 15' West 262.00 feet; thence NW'ly 206.65 feet along the arc of a curve to the right, having a radius of 400 feet and chord bearing N 37° 50' West 204.36 feet; thence Northerly 264.15 feet along the arc of a curve to the right, having a radius of 400 feet and chord bearing N 2° 41' West 278.21 feet; thence NE'ly 163.93 feet along the arc of a curve to the left, having a radius of 400 feet and chord bearing N 5° 55' 30" East 162.79 feet; thence Easterly 454.72 feet along the arc of a curve to the right, having a radius of 1200 feet and chord bearing S 82° 41' East 452.00 feet to the place of beginning.

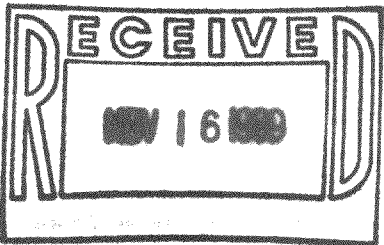
