Hamlin Est. which is a strip 204' wide N 45° extending from R.R. to center of Lake Geneva & Geneva Highway, parallel to N. line of said Section 6 and 525' south of said N. line.

R. 18 E.; thence east in S. line of said Sect. 31 112 rods; thence north over a cem. mon. 80 rods to a cem. mon. on the 1/8 Sect. line; thence west in the 1/8 line 112 rods to the west line of said Sect.; thence south in said west line 80 rods to place of beginning; containing 54 acres exclusive of R.R. A cem. mon. marks N. line at R.R. line.
