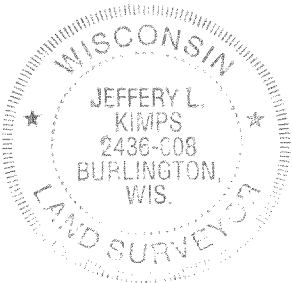


CAMELIA ROAD
