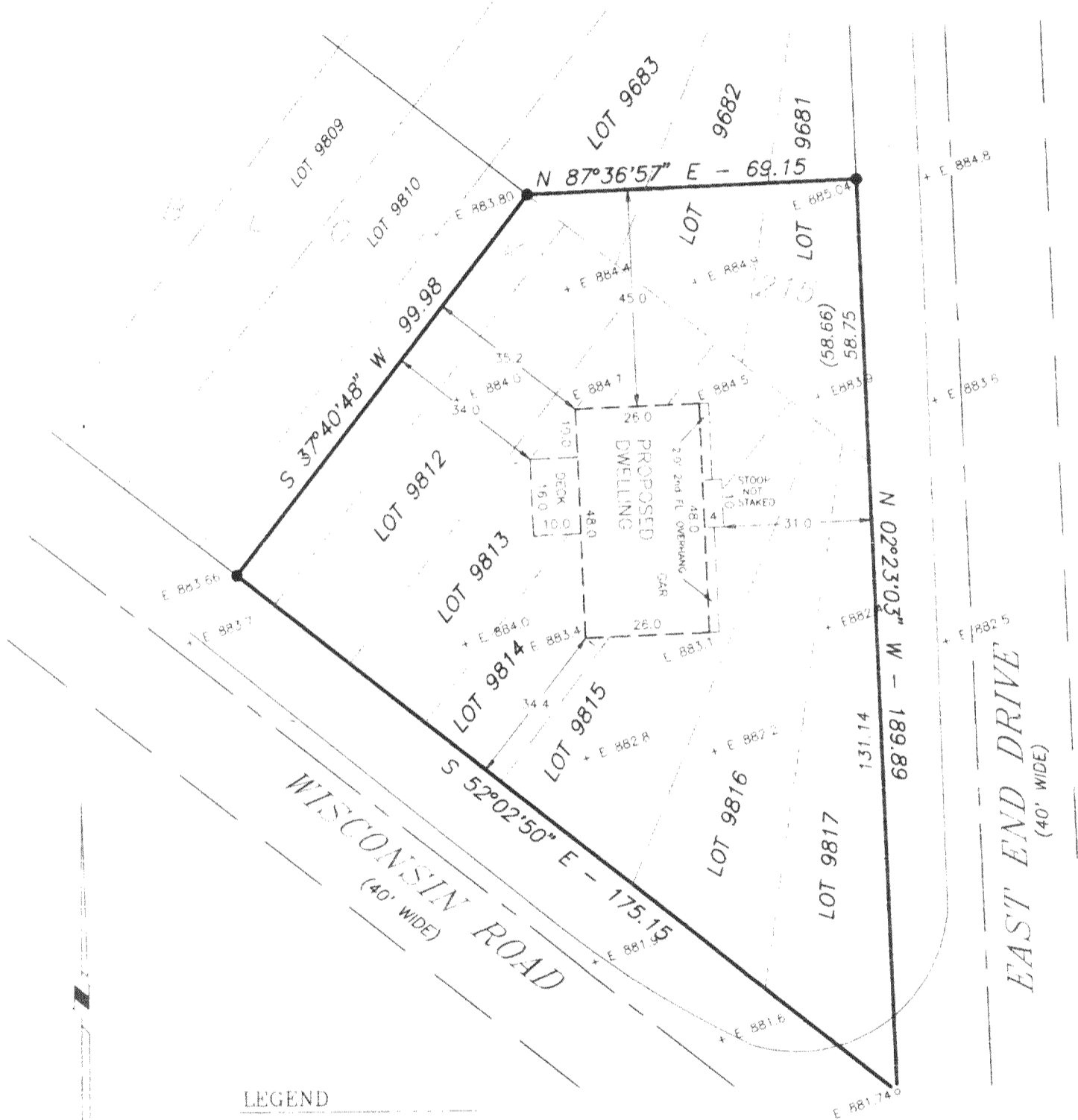


PLAT OF SURVEY

SAID PART OF LOTS 9681, 9682 AND 9683 IS DESCRIBED AS FOLLOWS: BEGIN AT THE SOUTHERLY MOST CORNER OF LOT 9681; THENCE 58.66 FEET NORTHERLY ALONG THE EAST LINE OF LOT 9681; THENCE WESTERLY 69.15 FEET AT RIGHT ANGLES TO THE EAST LINE OF LOT 9681 TO THE WESTERLY LINE OF LOT 9683; THENCE SOUTHEASTERLY 90.68 FEET ALONG THE SOUTHWESTERLY LINE OF LOTS 9683, 9682 AND 9681 TO THE POINT OF BEGINNING. 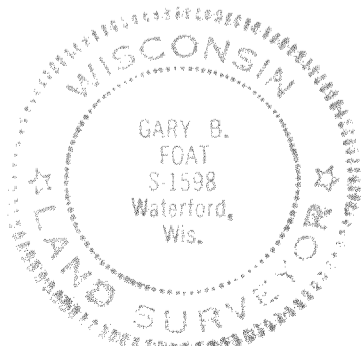
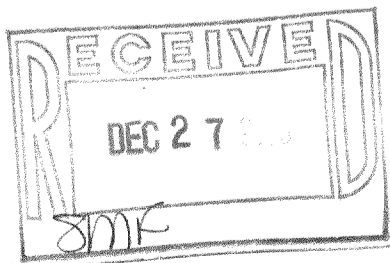
