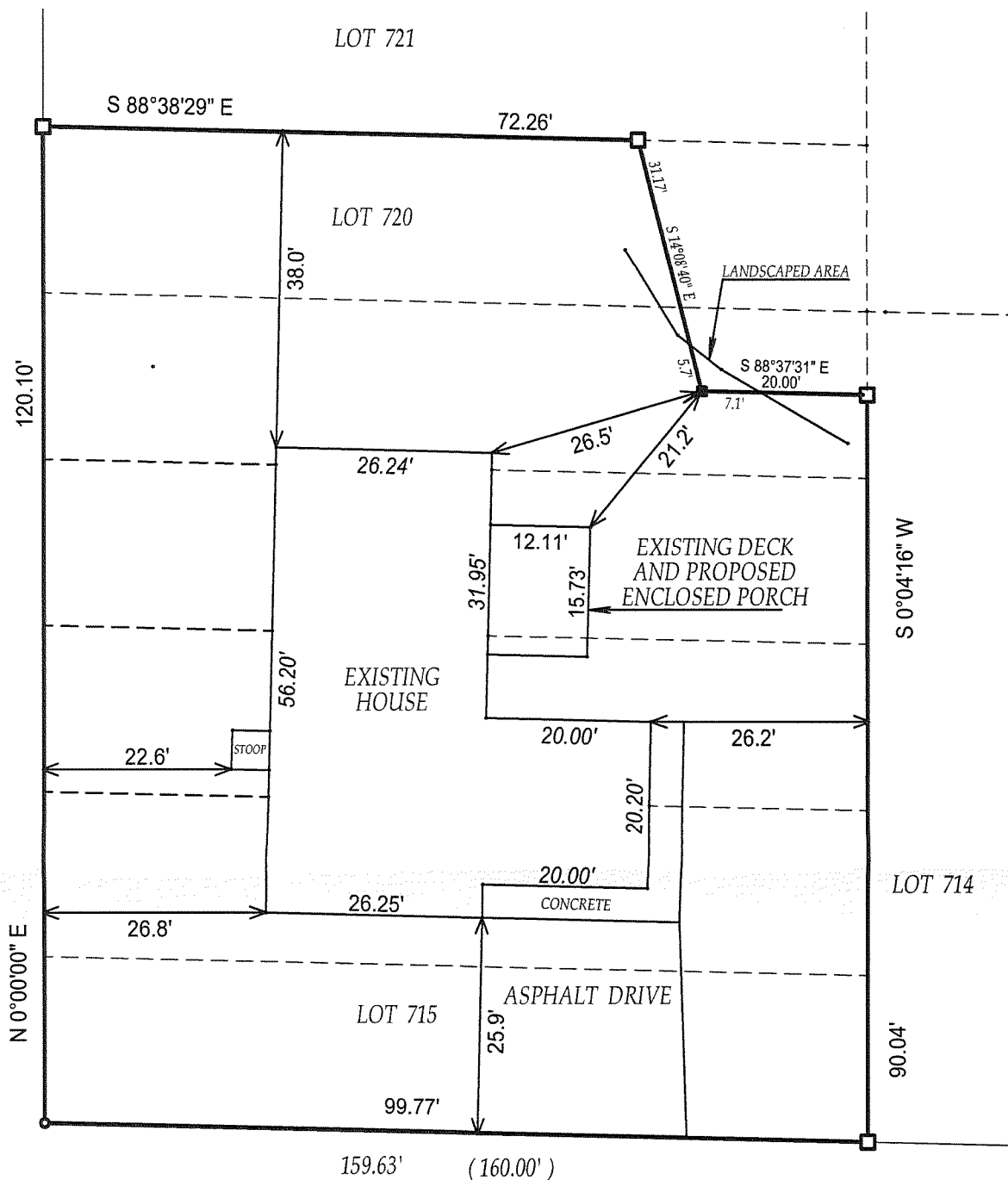

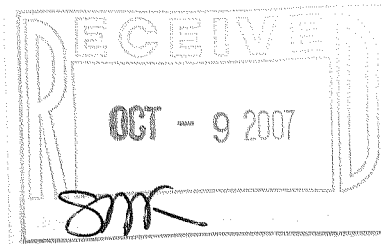
C.L. HIGHLAND DRIVE

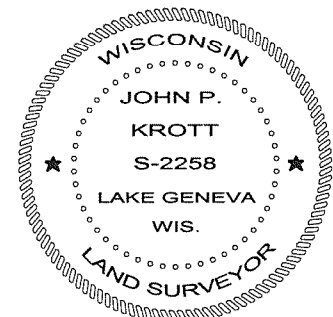
