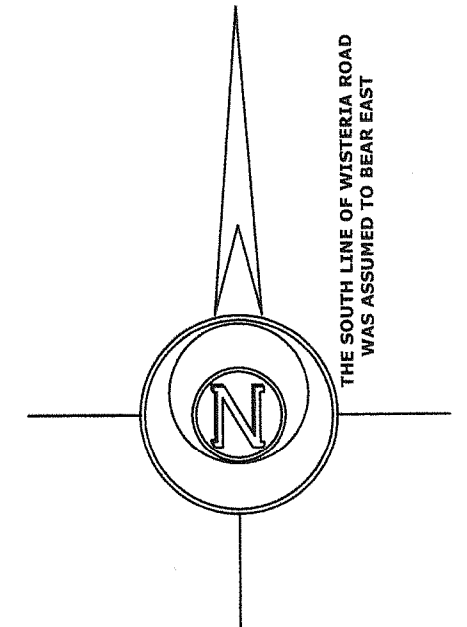
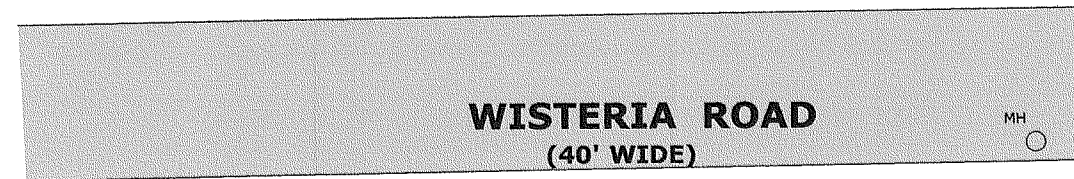
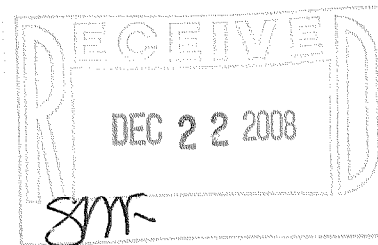

PLAT OF SURVEY

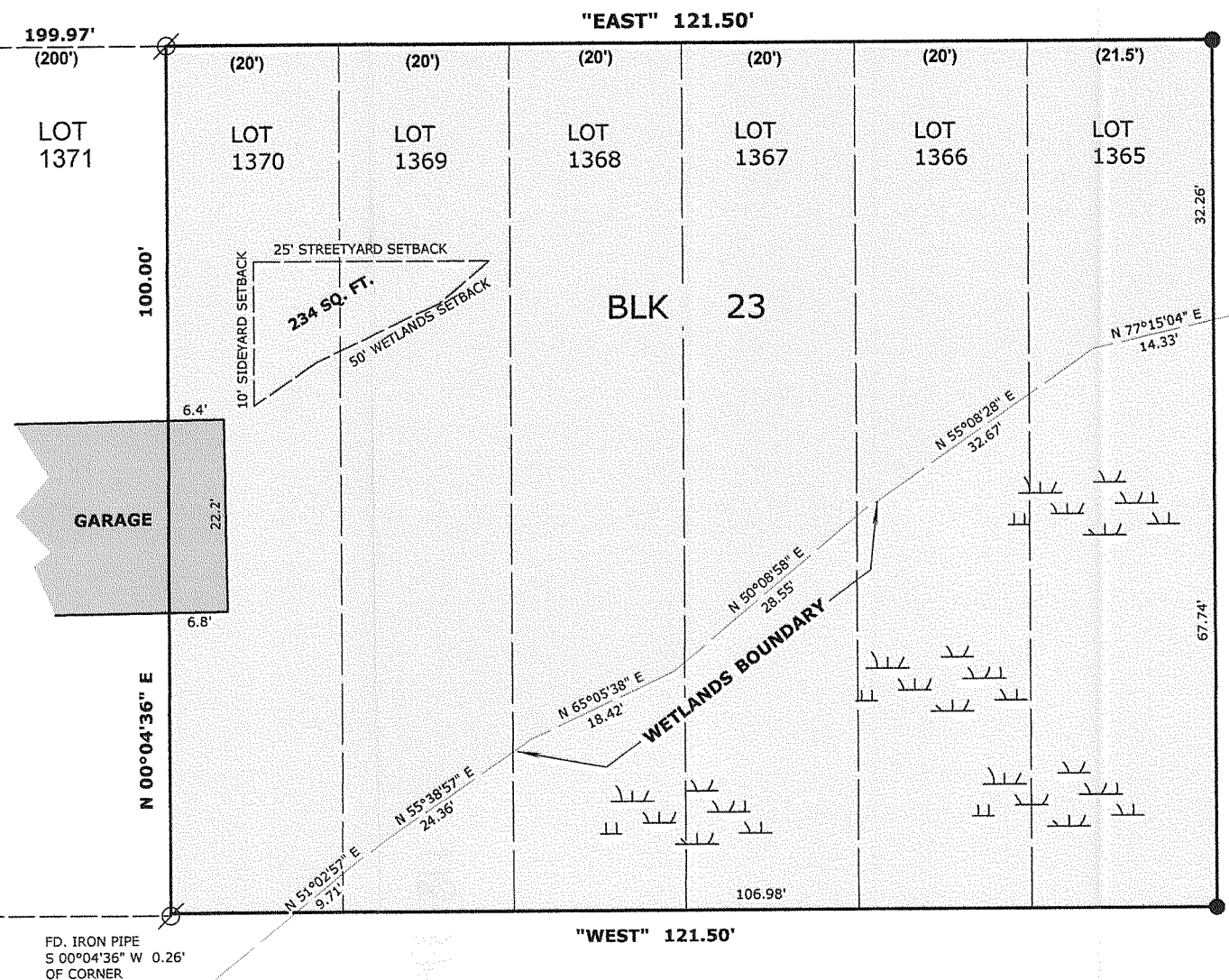

LEGAL DESCRIPTION FOR WETLANDS

All that portion of Lots 1365 thru 1370 (inclusive), Block 23, of Pell Lake Addition, located in the Northwest 1/4 of Section 23, Township 1 North, Range 18 East, Town of Bloomfield, Walworth Co., Wisconsin, more particularly described as follows: Commencing at the Northeast corner of said Lot 1365, Block 23, Pell Lake Addition; thence S 00°04'36" W. along the East line of said Lot 1365, 32.26 feet, to the POINT OF BEGINNING; thence continuing S 00°04'36" W, along said East line, 67.74 feet, to the Southeast corner of said Lot 1365; thence WEST, along the South line of said Lots 1365 thru 1370 (inclusive), 106.98 feet; thence leaving said South line, N 51°02'57" E, 9.71 feet; thence N 55°38'57" E, 24.36 feet; thence N 65°05'38" E, 18.42 feet; thence N 50°08'28" E, 32.67 feet; thence N 77°15'04" E, 14.33 feet, to the POINT OF BEGINNING. Containing 3,888 square feet more or less.
