

DESCRIPTION OF SURVEY

THAT PART OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 31, TOWN 2 NORTH, RANGE 15 EAST OF THE FOURTH PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE SOUTH LINE OF SAID SOUTHWEST QUARTER OF SECTION 31, WHICH IS 1600.34 FEET EAST OF THE SOUTHWEST CORNER THEREOF; THENCE NORTH 00 DEGREES 00 MINUTES 35 SECONDS EAST, ALONG A LINE 330.00 FEET EAST OF THE WEST LINE OF THE EAST HALF OF SAID SOUTHWEST QUARTER OF SECTION 31, 445.52 FEET; THENCE NORTH 76 DEGREES 55 MINUTES 00 SECONDS EAST, ALONG THE SOUTHERLY RIGHT-OF-WAY LINE OF THE CHICAGO, MILWAUKEE, SAINT PAUL, AND PACIFIC RAILWAY COMPANY, 532.95 FEET; THENCE SOUTH 00 DEGREES 00 MINUTES 00 SECONDS EAST, ALONG THE WEST LINE OF LOT 1 IN BLOCK 5, OF SIDNEY ALLEN'S ADDITION TO ALLEN'S GROVE, 249.98 FEET; THENCE SOUTH 76 DEGREES 55 MINUTES 00 SECONDS WEST, 22.79 FEET; THENCE SOUTH 00 DEGREES 00 MINUTES 00 SECONDS WEST, 22.79 FEET; THENCE SOUTH 00 DEGREES 00 MINUTES 00 SECONDS EAST, ALONG A LINE 22.2 FEET WEST OF THE WEST LINE OF SAID LOT 1 IN BLOCK 5, 309.45 FEET; THENCE SOUTH 89 DEGREES 49 MINUTES 10 SECONDS WEST 496.99 FEET, TO THE POINT OF BEGINNING, AND CONTAINING 5.48 ACRES, MORE OR LESS, IN WALWORTH COUNTY, WISCONSIN.
