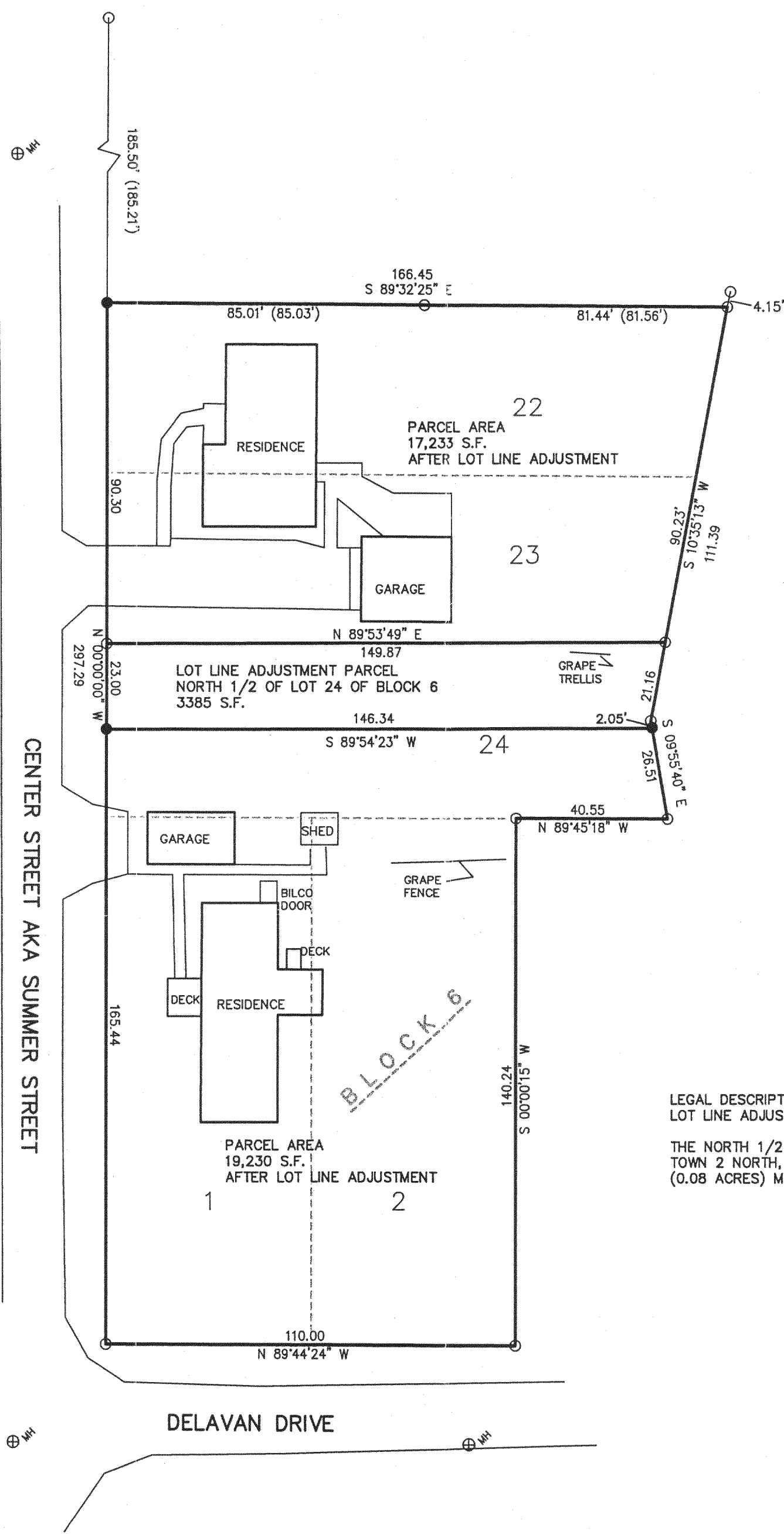
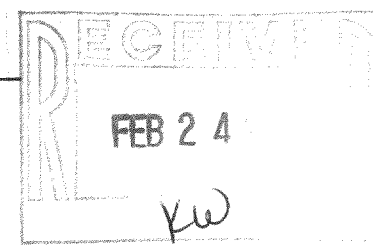

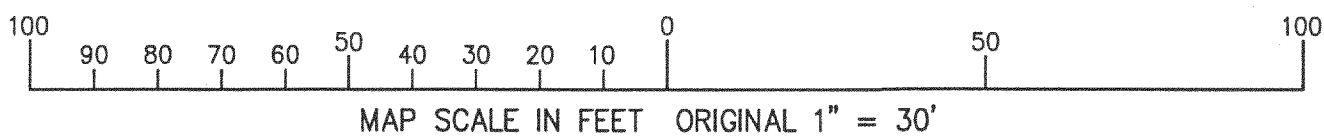


CENTER STREET AKA SUMMER STREET
