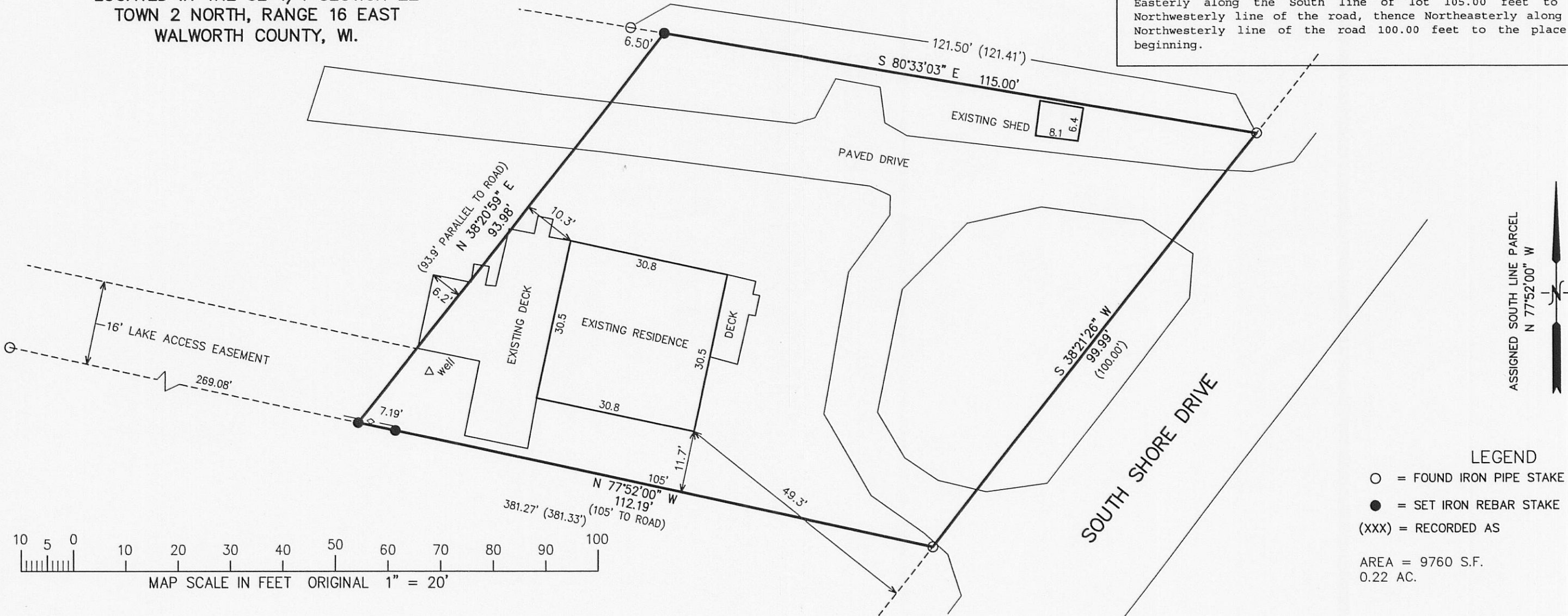

WALWORTH COUNTY, WI.



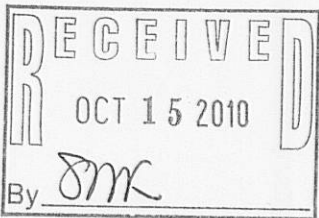
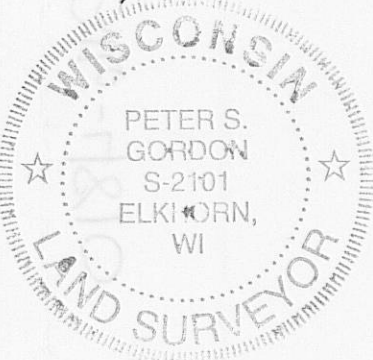
