
PLAT OF SURVEY

PART OF THE SE 1/4 OF SECTION 22 TOWN 2 NORTH, RANGE 16 EAST WALWORTH COUNTY, WISCONSIN

4. The land referred to in this policy is described as follows:

A part of the Southeast 1/4 of Section 22, Township 2 North, Range 16 East, being the Town of Delavan, County of Walworth, Wisconsin, and described as follows, to-wit: Beginning at a stake in the center of the road sometimes called the Lake Road and Which stake is on the North line of the land conveyed to said George B. Mereness, the deed of which conveyance is on record in the Register of Deeds office in and for said County, in Volume 132 of Deeds, on page 561 and being also 28.58 chains (1886.3 feet) North and about 543 feet North 87° West of the Southeast corner of said Section 22; thence North 87° West along the North line of said Mereness land 511 feet more or less to the shore of Delavan Lake at low water line; thence Southwesterly along the shore of said Lake at low water line 100 feet more or less to a point; thence South 87° East being on a line parallel with and 100 feet South of (measuring at right angles to) the North line of said Mereness land 463.5 feet more or less to the center said Lake Road; thence Northeasterly along the center of said road 120.7 feet to the place of beginning.
