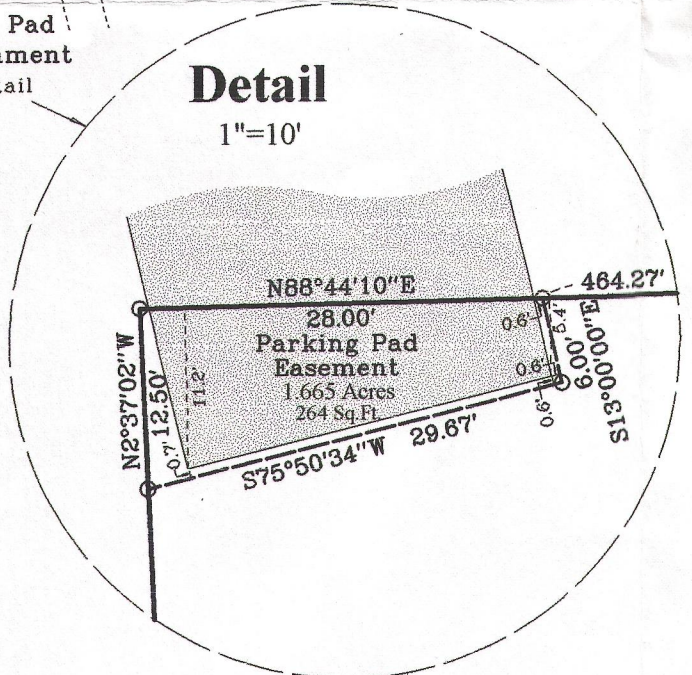

Legal Description of Proposed Parking Pad Easement Area

A parcel of land located in the Southwest 1/4 of Section 6, Town 2 North, Range 16 East, Town of Delavan, Walworth County, Wisconsin, described as follows: Commencing at the Center 1/4 Corner of said Section 6, being the Northeast corner of Certified Survey Map No. 3148; thence South 88°44'10\" West, along the North line of said Southwest 1/4 of Section 6, 41.22 feet to an iron rod marking the Northeast corner of Lot 1 of said Certified Survey Map No. 3148; thence South 1°38'46\" East, along the East line of said Lot 1, 66.00 feet to an iron rod; thence South 88°44'10\" West, along a Southerly line of said Lot 1, 464.27 feet to an iron pipe and the Point of Beginning; thence South 13°00'00\" East 6.00 feet to an iron pipe; thence South 75°50'34\" West 29.67 feet to an iron pipe on an Easterly line of said Lot 1; thence North 2°37'02\" West, along said Easterly line, 12.50 feet to an iron pipe; thence North 88°44'10\" East, along a Southerly line of said Lot 1, 28.00 feet to the Point of Beginning.

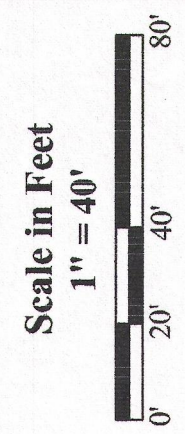
