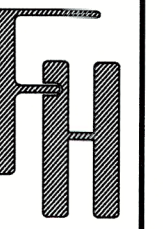


PLAT OF SURVEY LOTS 97 & 98, LAKE DELAVAN HIGHLANDS

TOWN OF DELAVAN, WALWORTH COUNTY, WISCONSIN



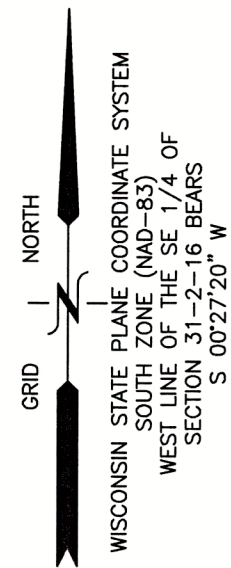

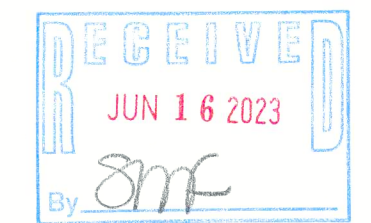
