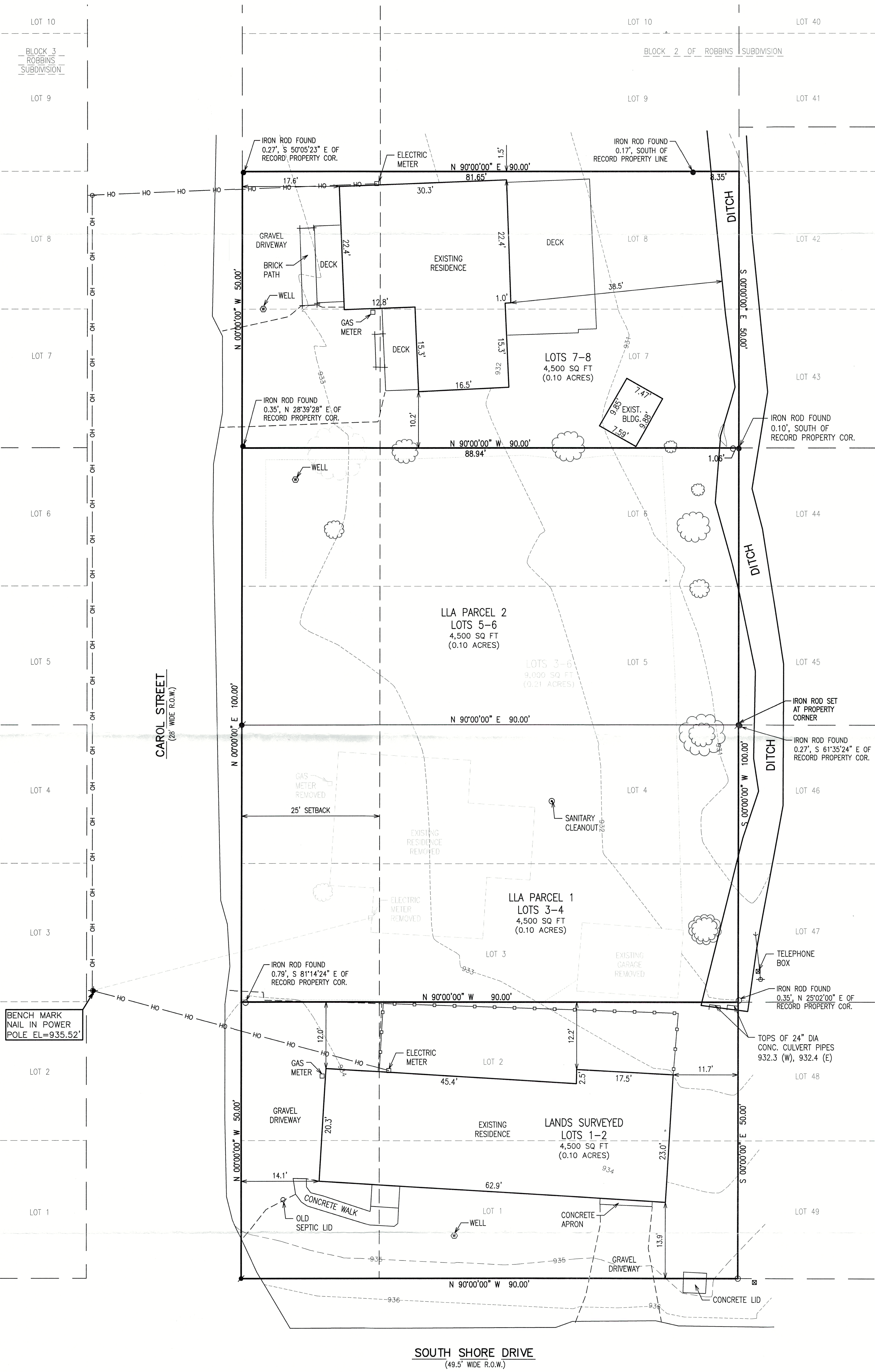


PLAT OF SURVEY – LOT LINE ADJUSTMENT

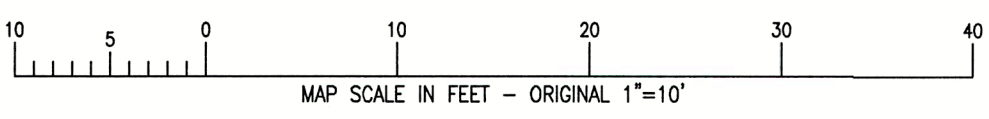
