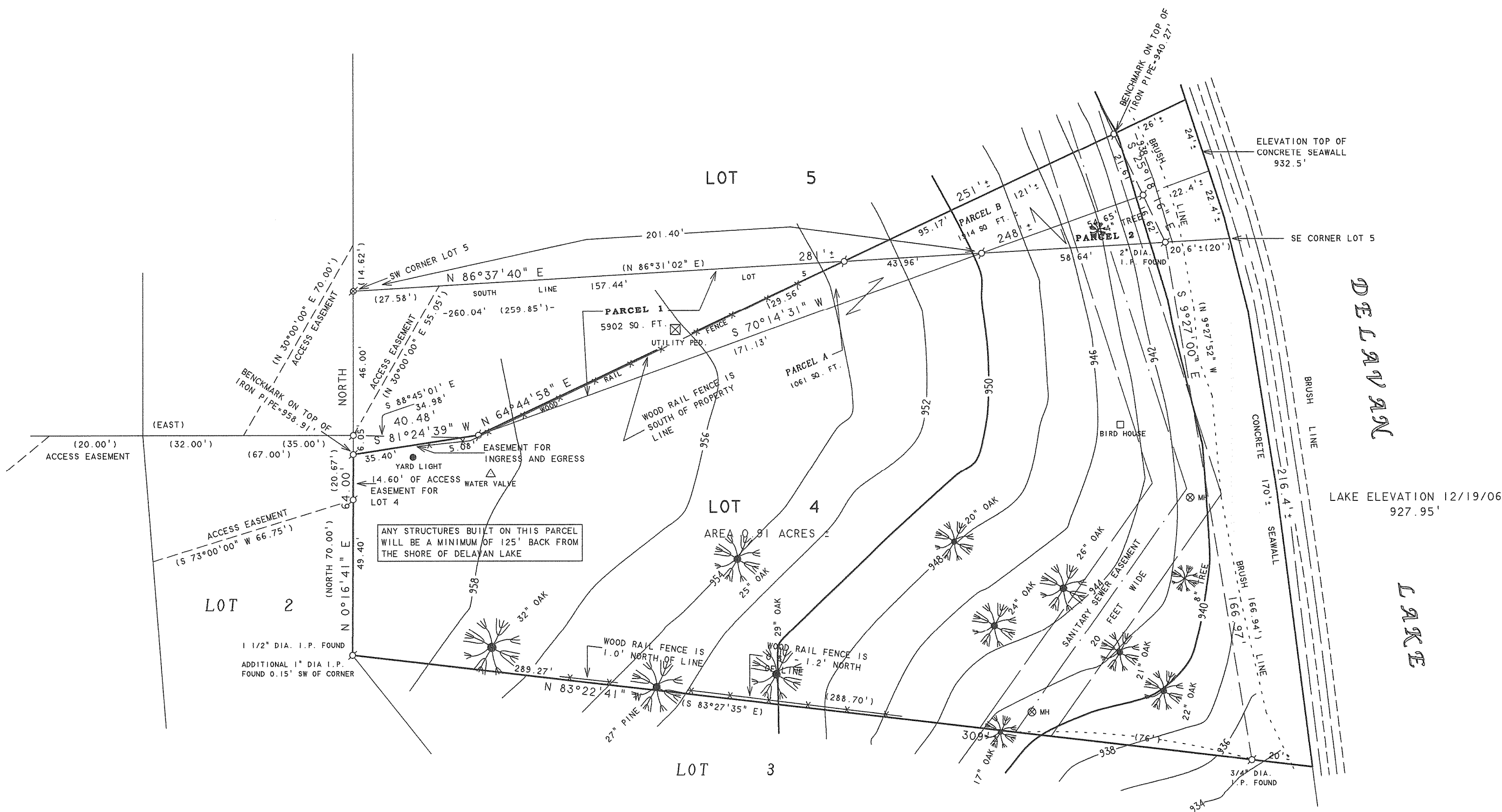

TOPOGRAPHIC SURVEY OF

LOT 4 OF THE ISLAND OF LAKE DELAVAN, LOCATED IN T2N, R16E, WALWORTH COUNTY, WISCONSIN, EXCEPTING THEREFROM THAT PORTION OF LOT 4 WHICH IS DESCRIBED AS FOLLOWS:

PARCEL 1 - BEGINNING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN; THENCE N 86°37'40" E 201.40 FEET ALONG THE SOUTH LINE OF SAID LOT 5; THENCE S 70°14'31" W 171.13 FEET; THENCE S 81°24'39" W 40.48 FEET TO THE WEST LINE OF LOT 4 OF THE ISLAND OF LAKE DELAVAN; THENCE N 0°16'41" E 6.05 FEET ALONG THE WEST LINE OF SAID LOT 4; THENCE NORTH 46.00 FEET ALONG THE WEST LINE OF SAID LOT 4 TO THE SOUTHWEST CORNER OF SAID LOT 5 AND THE PLACE OF BEGINNING, CONTAINING 0.14 ACRES OF LAND, MORE OR LESS.

AND INCLUDING THAT PORTION OF LOT 4 WHICH IS DESCRIBED AS FOLLOWS:

PARCEL A - BEGINNING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN; THENCE N 86°37'40" E 157.44 FEET ALONG THE SOUTH LINE OF SAID LOT 5 TO THE PLACE OF BEGINNING; THENCE CONTINUE N 86°37'40" E ALONG THE SOUTH LINE OF SAID LOT 5, 43.96 FEET; THENCE S 70°14'31" W 171.13 FEET; THENCE N 64°44'58" E 129.56 FEET TO THE SOUTH LINE OF SAID LOT 5 AND THE PLACE OF BEGINNING, CONTAINING 0.02 ACRES OF LAND, MORE OR LESS. PARCEL A IS TO BE ADDED TO LOT 4.

ALSO INCLUDING THAT PORTION OF LOT 5 OF THE ISLAND OF LAKE DELAVAN WHICH IS DESCRIBED AS FOLLOWS:

PARCEL 2 - COMMENCING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN; THENCE N 86°37'40" E 201.40 FEET ALONG THE SOUTH LINE OF SAID LOT 5 TO THE PLACE OF BEGINNING; THENCE N 70°14'31" E 77.05 FEET TO THE SHORE OF DELAVAN LAKE; THENCE SOUTHEASTERLY ALONG SAID SHORE OF DELAVAN LAKE, 22.4 FEET, MORE OR LESS TO THE SOUTHEAST CORNER OF SAID LOT 5 WHICH IS LOCATED N 86°37'40" E 79.24 FEET FROM THE PLACE OF BEGINNING; THENCE S 86°37'40" W 79.24 FEET ALONG THE SOUTH LINE OF SAID LOT 5 TO THE PLACE OF BEGINNING, CONTAINING 0.02 ACRES OF LAND, MORE OR LESS.

ALSO INCLUDING THAT PORTION OF LOT 5 OF THE ISLAND OF LAKE DELAVAN WHICH IS DESCRIBED AS FOLLOWS:

PARCEL B - COMMENCING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN; THENCE N 86°37'40" E 157.44 FEET ALONG THE SOUTH LINE OF SAID LOT 5; THENCE CONTINUE N 86°37'40" E 43.96 FEET ALONG THE SOUTH LINE OF SAID LOT 5 TO THE PLACE OF BEGINNING; THENCE S 86°37'40" W 43.96 FEET; THENCE N 64°44'58" E 121 FEET, MORE OR LESS TO THE SHORE OF DELAVAN LAKE; THENCE SOUTHEASTERLY ALONG THE SHORE OF DELAVAN LAKE, 24 FEET, MORE OR LESS TO A POINT WHICH IS N 70°14'31" E 77 FEET, MORE OR LESS FROM THE PLACE OF BEGINNING; THENCE S 70°14'31" W 77 FEET, MORE OR LESS TO THE PLACE OF BEGINNING, CONTAINING 0.04 ACRES OF LAND, MORE OR LESS. PARCEL B IS TO BE ADDED TO LOT 4.

TOGETHER WITH A EASEMENT FOR INGRESS AND EGRESS - COMMENCING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN, LOCATED IN T2N, R16E, WALWORTH COUNTY, WISCONSIN; THENCE SOUTH ALONG THE WEST LINE OF LOT 4, 46.00 FEET TO THE PLACE OF BEGINNING; THENCE S 88°45'01" E 34.98 FEET; THENCE S 81°24'39" W 35.40 FEET TO THE WEST LINE OF LOT 4; THENCE N 0°16'41" E ALONG SAID WEST LINE, 6.05 FEET TO THE PLACE OF BEGINNING, CONTAINING 106 SQ. FT. OF LAND MORE OR LESS.
