

LEGAL DESCRIPTIONS

Parcel 1: Parts of Section numbered Twenty-eight (28), in Township Numbered Two (2) North of Range Numbered Sixteen (16) East, in the Town of Delavan, County of Walworth and State of Wisconsin, more fully described as follows, to-wit: Beginning 31 feet South of the Southwest corner of a piece of land conveyed by deed dated July 19, 1890, by Mary Shannahan and Timothy Shannahan to Henry C. Gill and recorded in the Register's Office of the County of Walworth, State of Wisconsin, in Volume 82 of Deeds, Page 13; thence South 10-1/2 feet on a line in a line with the West side of the above-mentioned conveyed piece; thence East parallel with the North line of said tract deeded to Jane Holland on the 19th day of September, 1898, to the Northwest side of said highway; thence Northeasterly along said Northwest side of said highway to a point, which is directly East of the point of beginning; thence West parallel with the North line of said tract deeded to Jane Holland, to the point of beginning.

Parcel 2: Also an undivided 1/4 interest in the following tract, to-wit: Beginning 42 feet South of the Southwest corner of a piece of land conveyed by deed dated July 19, 1890, by Mary Shannahan and Timothy Shannahan to Henry C. Gill and recorded in the said Register's office in Volume 82 of Deeds, Page 13; thence South 17 feet on a line, in line with the West side of the above-mentioned conveyed piece; thence East parallel with the North line of said tract deeded to Jane Holland on the 19th day of September, 1898, to the Northwest side of said highway; thence Northeasterly along said Northwest side of said highway to a point, which is directly East of the point of beginning; thence West parallel with the North line of said tract deeded to Jane Holland to the point of beginning.

Parcel 3: Also Lot numbered Three (3) as designated on a map of plat of the Rockford Colony, on the West One-half (1/2) of the West One half (1/2) of Section Numbered Twenty-eight (28), Township Numbered Two (2) North, of Range Numbered Sixteen (16) East, in the Town of Delavan, Walworth County, Wisconsin. Subject, however, to the right of way of the other lot owners, their heirs and assigns of said Colony over and along a strip of land 16 1/2 feet in width on the East side of said Lot 3. Together with the joint right of way for ingress and egress over and along a strip of land 16 1/2 feet in width on each side of the centerline of said map or plat, the whole length thereof, which strip of land is intended to be and shall be as and for a right of way to and for the present lot owners of said Colony, their respective heirs and assigns forever. Also the right of way jointly with the other lot owners of said Colony over and along a strip of land 12 feet in width between Lots 4 and 6 in said plat designated as an alley.
