

2 PROPOSED LOT LINE ADJUSTMENTS BETWEEN LOT 4 AND LOT 5 OF THE ISLAND OF LAKE DELAVAN, LOCATED IN T2N.RIGE, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS:

PARCEL I - BEGINNING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN: THENCE N 86°37'40" E 201.40 FEET ALONG THE SOUTH LINE OF SAID LOT 5; THENCE S 70°14'31" W 171.13 FEET; THENCE S 81°24'39" W 40.48 FEET TO THE WEST LINE OF LOT 4 OF THE ISLAND OF LAKE DELAVAN: THENCE N 0°16'41" E 6.05 FEET ALONG THE WEST LINE OF SAID LOT 4; THENCE NORTH 46.00 FEET ALONG THE WEST LINE OF SAID LOT 4 TO THE SOUTHWEST CORNER OF SAID LOT 5 AND THE PLACE OF BEGINNING. CONTAINING 0.14 ACRES OF LAND, MORE OR LESS. PARCEL I IS TO BE ADDED TO LOT 5.

PARCEL 2 - COMMENCING AT THE SOUTHWEST CORNER OF LOT 5 OF THE ISLAND OF LAKE DELAVAN; THENCE N 86°37'40" E 201.40 FEET ALONG THE SOUTH LINE OF SAID LOT 5 TO THE PLACE OF BEGINNING; THENCE N 70°14'31" E 77.05 FEET TO THE SHORE OF DELAVAN LAKE; THENCE SOUTHEASTERLY ALONG SAID SHORE OF DELAVAN LAKE, 22.4 FEET, MORE OR LESS TO THE SOUTHEAST CORNER OF SAID LOT 5 WHICH IS LOCATED N 86°37'40" E 79.24 FEET FROM THE PLACE OF BEGINNING; THENCE S 86°37'40" W 79.24 FEET ALONG THE SOUTH LINE OF SAID LOT 5 TO THE PLACE OF BEGINNING, CONTAINING 0.02 ACRES OF LAND, MORE OR LESS.


