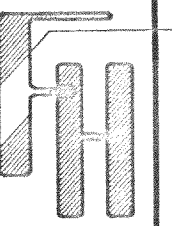


PLAT OF SURVEY LOT 6 COUNTRY VIEW SUBDIVISION

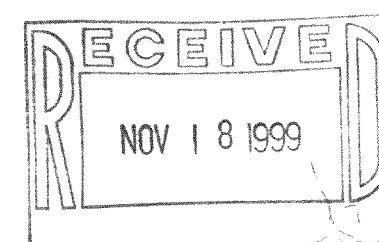
