

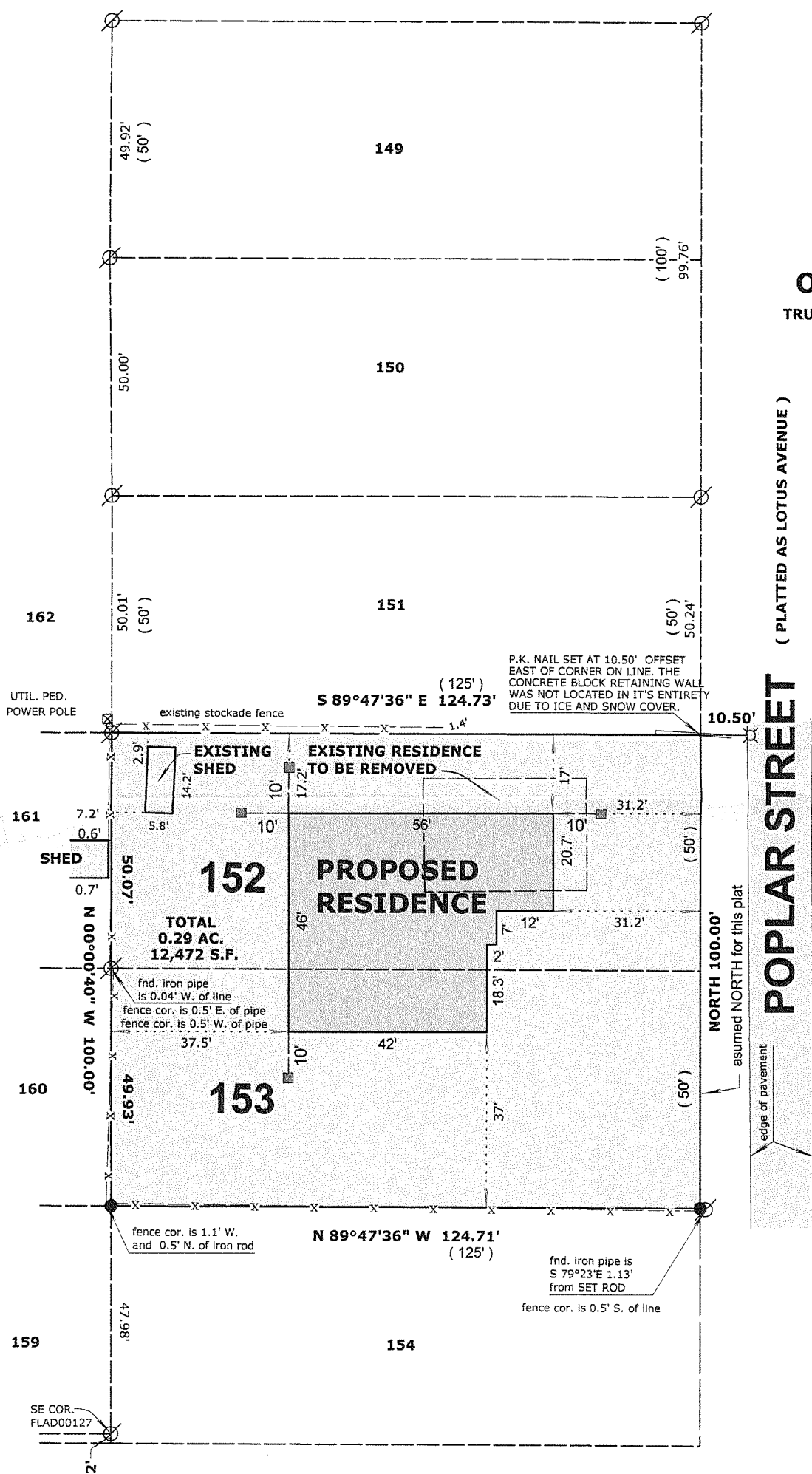

 TOWN OF DELAVAN, WALWORTH COUNTY, WISCONSIN.**

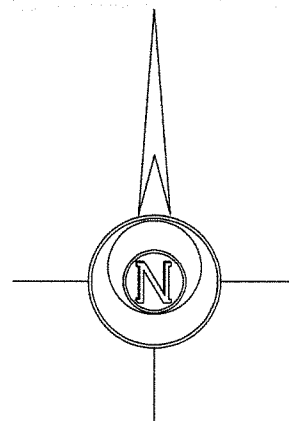

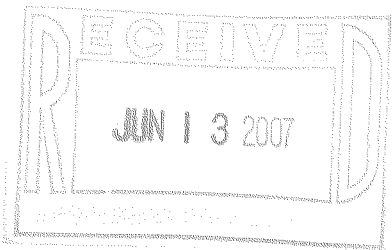
