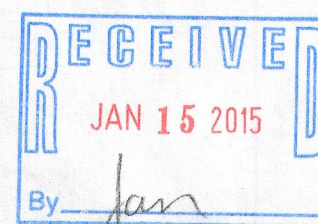


BASIS OF BEARING OF THIS PLAT: THE EAST LINE OF LOT 12 WAS ASSUMED TO BEAR SOUTH.
