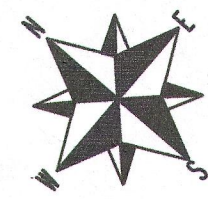


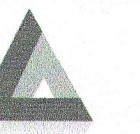

LEGAL DESCRIPTION

Part of Lot 9 of Cedar Point Subdivision, according to the recorded plat thereof, said land being described as follows:
Parcel 1: Commencing at the Southwest corner of Lot 10 of said Subdivision, thence South 0° 9' West along the West line of said Lot 9, 136.8 feet; thence South 89° 54' East 120 feet, thence South 159.63 feet to the place of beginning, thence continue South 55.41 feet, thence North 88° 30' East 50.02 feet, thence North 68° 38' East 20.71 feet, thence North 49° 31' East 38.90 feet, thence North 60° 40' West 38.86 feet; thence North 88° West 65.06 feet to the place of beginning.
Parcel 2: Commencing at the Southwest corner of Lot 10 of said Subdivision, thence South 0° 09' West along the West line of said Lot 9, 136.8 feet; thence South 89° 54' East 120 feet, thence South 215.04 feet, thence North 88° 30' East 50.02 feet to the place of beginning, thence continue South 64.89 feet, thence North 88° 30' East 50.02 feet; thence North 68° 38' East 20.71 feet; thence North 49° 31' East 38.90 feet, thence North 8° 51' East 34.11 feet; thence North 89° 21' West 42.59 feet; thence South 70° 02' West 8.52 feet; thence North 89° 21' West 53.72 feet to the place of beginning. EXCEPTING therefrom Parcel 1, described above. Said land being in the Town of Delavan, County of Walworth and State of Wisconsin.
