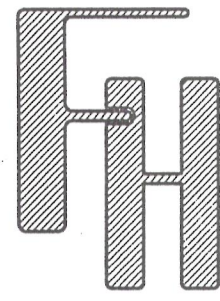

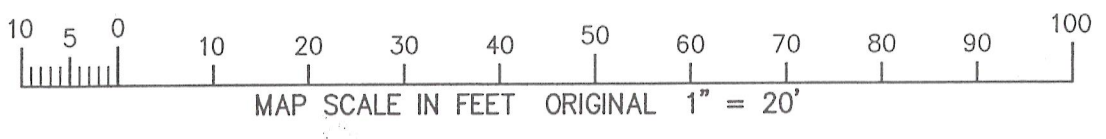
RECORD POSITION SOIL
