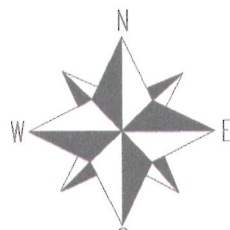

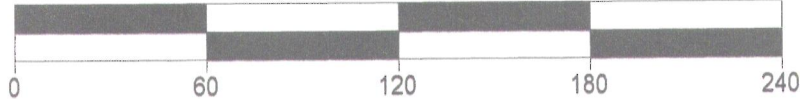

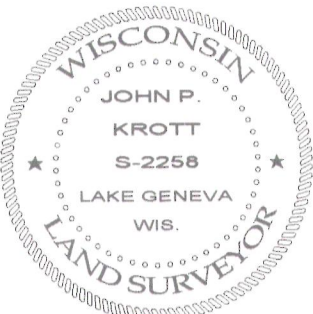


LOT 1 CERTIFIED SURVEY MAP NO. 1040
