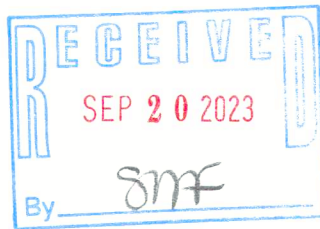

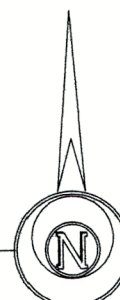

PLAT OF SURVEY PROPOSED LOT LINE ADJUSTMENT



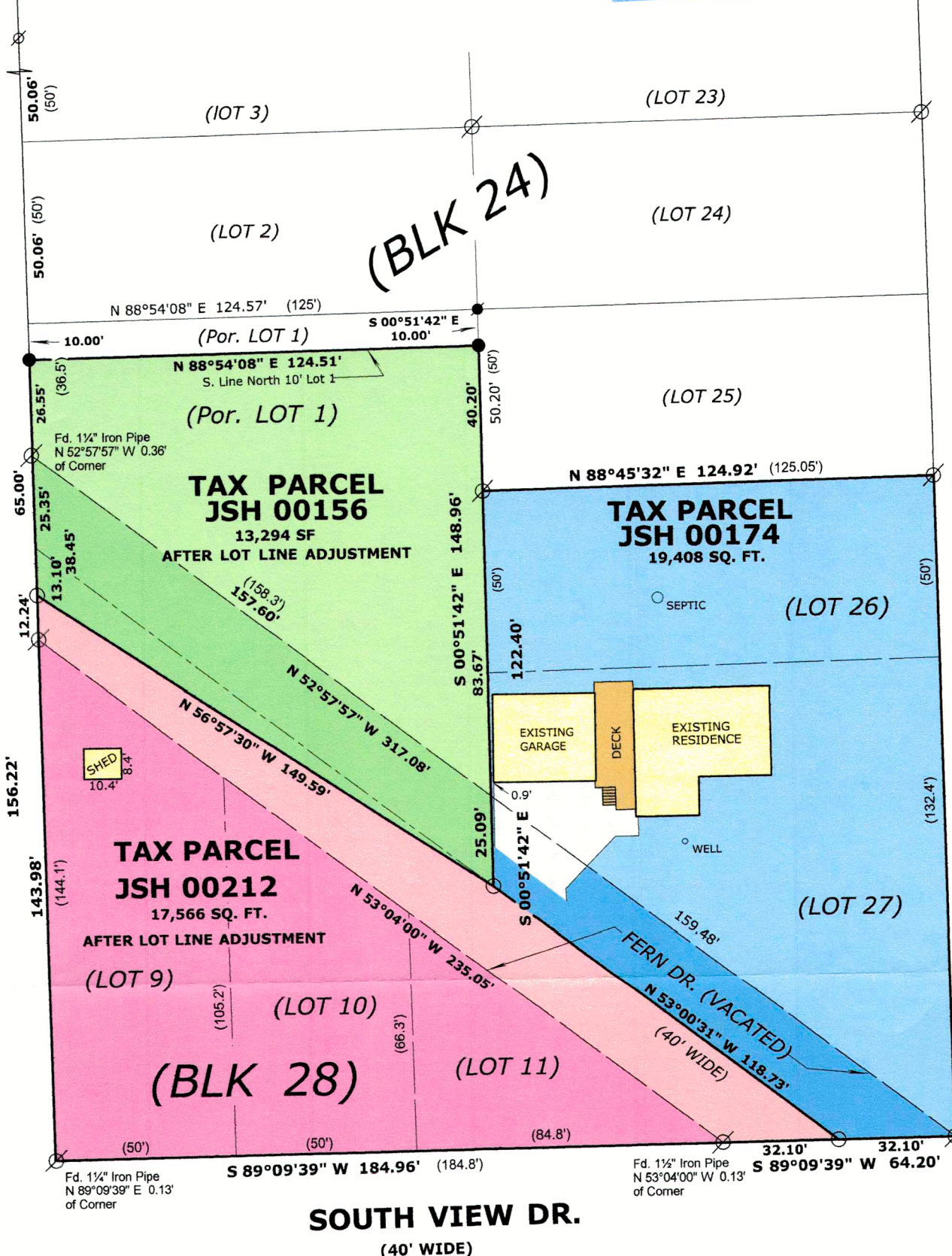
Center of Section
