REZONE LEGAL DESCRIPTION

A PARCEL OF LAND LOCATED IN THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 14 AND THE NORTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 23, TOWN 2 NORTH, RANGE 17 EAST, TOWN OF GENEVA, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCE AT THE NORTH 1/4 CORNER OF SAID SECTION 23; THENCE S 88°40'45" E ALONG THE NORTH LINE OF SAID SECTION 1707.97 FEET TO THE NORTHWEST CORNER OF CERTIFIED SURVEY MAP NO. 2238 AND THE POINT OF BEGINNING; THENCE N 49°16'22" E ALONG THE CENTERLINE OF BOWERS ROAD 460.72 FEET; THENCE S 8°15'29" E ALONG THE CENTERLINE OF A 50 FOOT WIDE EASEMENT 340.19 FEET; THENCE S 4°29'00" E ALONG SAID CENTERLINE 293.75 FEET TO A POINT IN THE NORTH LINE OF LOT 1 OF SAID CERTIFIED SURVEY MAP NO. 2238; THENCE N 89°14'15" W ALONG SAID LINE 151.78 FEET TO A POINT IN THE WESTERLY LINE OF SAID CERTIFIED SURVEY MAP; THENCE N 0°45'50" E ALONG SAID WESTERLY LINE 280.00 FEET; THENCE N 87°31'30" W 312.07 FEET TO A POINT IN THE CENTERLINE OF BOWERS ROAD; THENCE N 49°16'22" E ALONG SAID CENTERLINE 51.26 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 2.66 ACRES OF LAND MORE OR LESS.

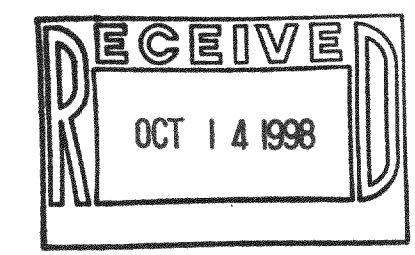
