

Plat of Survey

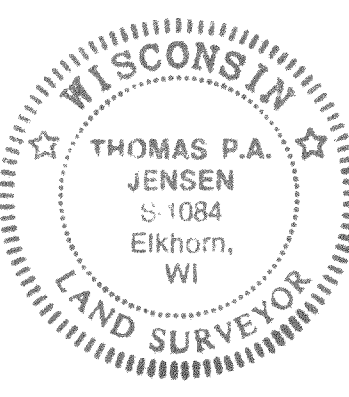
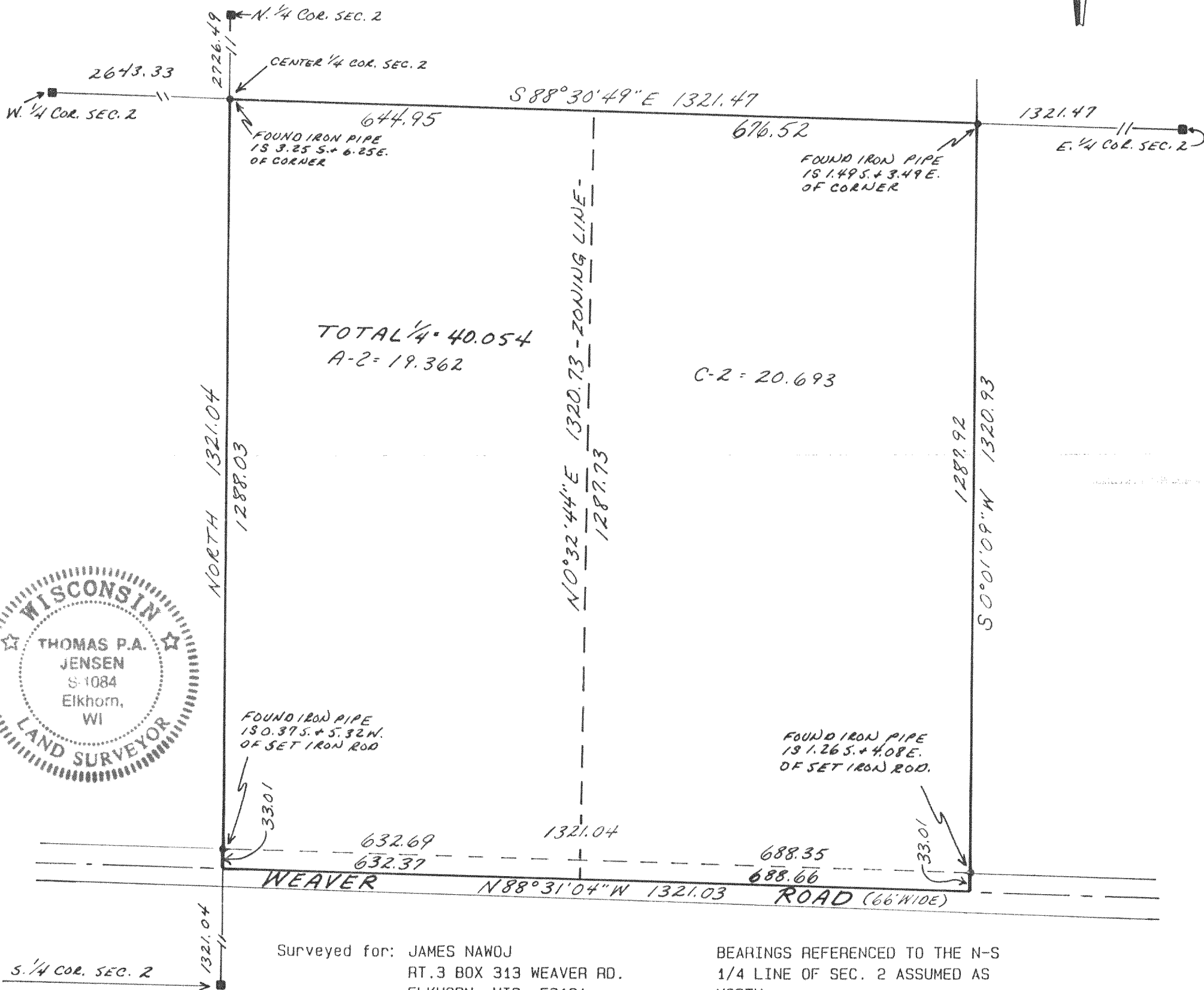

The Northwest 1/4 of the Southeast 1/4 of Section 2, Town 2 North, Range 17 East, Town of Geneva, Walworth County, Wisconsin, more particularly described as follows: Commence at the South 1/4 Corner of said Section 2; thence NORTH, along the North-South 1/4 line of said Section 2, 1321.04 feet to the centerline of Weaver Road and the Point of Beginning; thence continue NORTH, along said 1/4 line, 1321.04 feet to the Center 1/4 Corner of said Section 2; thence S 88°30'49" E, along the East-West 1/4 line of said Section 2, 1321.47 feet; thence S 0°01'09" W, along the East line of the West 1/2 of the Southeast 1/4 of said Section 2, 1320.93 feet; thence N 88°31'04" W, along the South line of the North 1/2 of the Southeast 1/4 of said Section 2 and the centerline of Weaver Road, 1321.03 feet to the Point of Beginning.

Said Parcel contains 40.054 acres of land, more or less.

NOTE: Zoning line as shown is based on the location of said line as drawn on the Walworth County zoning maps and as field located.

NOTE: This parcel was surveyed in 1982 by Daniel D. Cooper and was monumented with iron pipe. That survey was done prior to the Section Corners being located and therefore was of the 1/4 1/4 as fenced. Ties to these iron pipes are shown on this map.



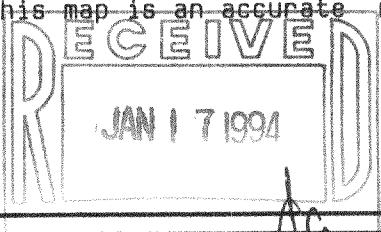
