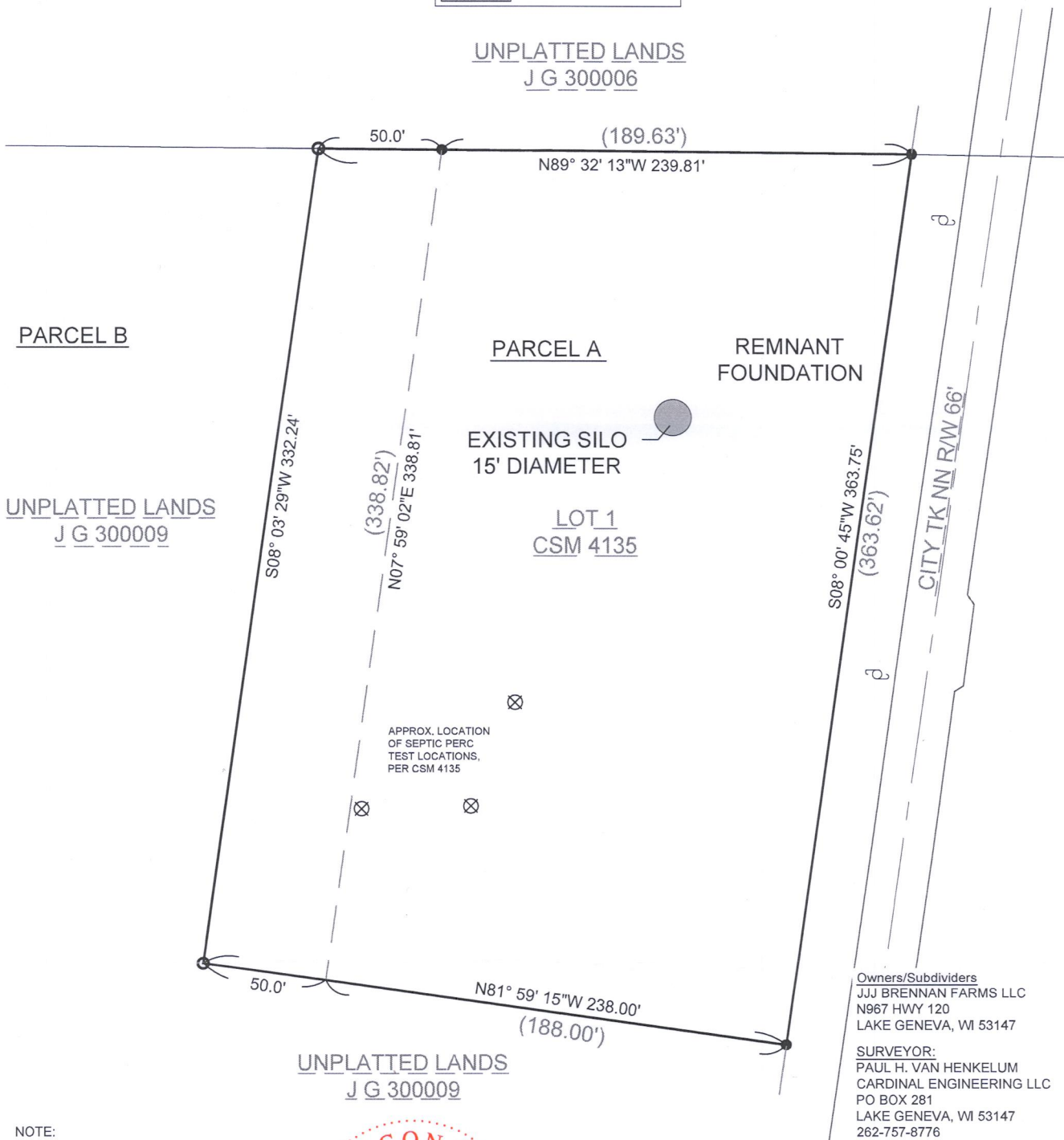
Part of the SE 1/4 of Section 3 in Township 2 North, Range 17 East, Town of Geneva, Walworth County, Wisconsin.

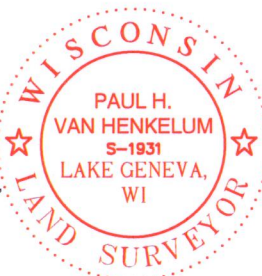
