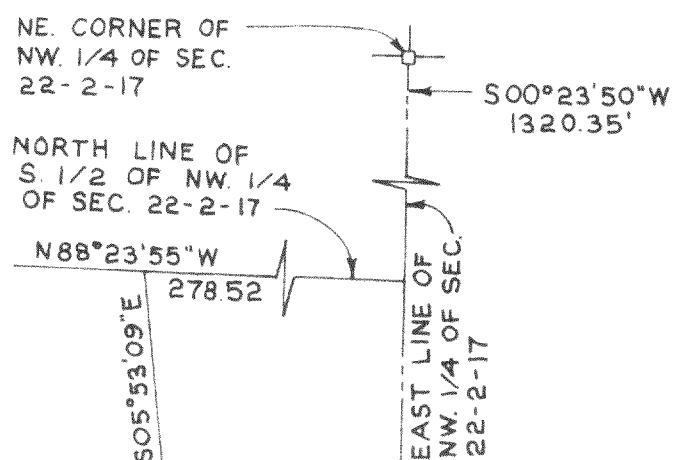

PLAT OF SURVEY

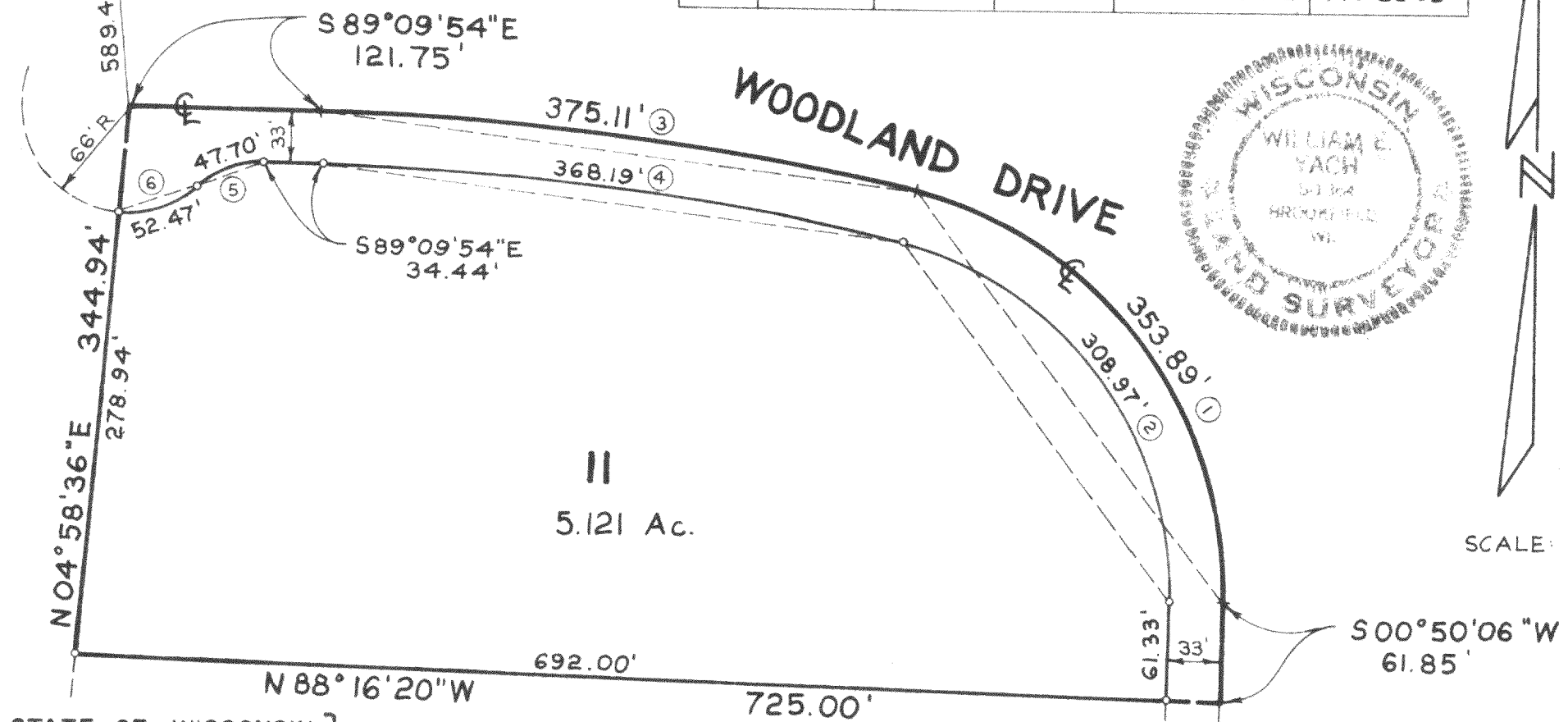
PREPARED FOR: Parcel 11 - ROYAL GLEN WOODLANDS

DESCRIPTION: That part of the Northeast 1/4 and the Northwest 1/4 of Section 22, Town 2 North, Range 17 East, in the Town of Geneva, Walworth County, Wisconsin, bounded and described as follows:

Commencing at a point in the East line of said Northwest 1/4 Section; 1320.35 feet S 00° 23' 50" W of the Northeast corner of said Northwest 1/4 Section; thence N 88° 23' 55" W, along the North line of the South 1/2 of said 1/4 Section, 278.52 feet to a point; thence S 05° 53' 09" E, 589.41 feet to the point of beginning; thence S 89° 09' 54" E, 121.75 feet to a point of curve; thence easterly along a curved line (having a radius of 1788.86 feet with its center to the south and a chord 374.42 feet in length which bears S 83° 09' 28" E), an arc distance of 375.11 feet to a point of compound curve; thence southeasterly along a curved line (having a radius of 260.00 feet with its center to the southwest and a chord 327.20 feet in length which bears S 38° 09' 27.5" E), an arc distance of 353.89 feet to a point of tangency; thence S 00° 50' 06" W, 61.85 feet to a point; thence N 88° 16' 20" W, 725.00 feet to a point; thence N 04° 58' 36" E, 344.94 feet to the point of beginning. Containing therein 5.121 acres of land.
