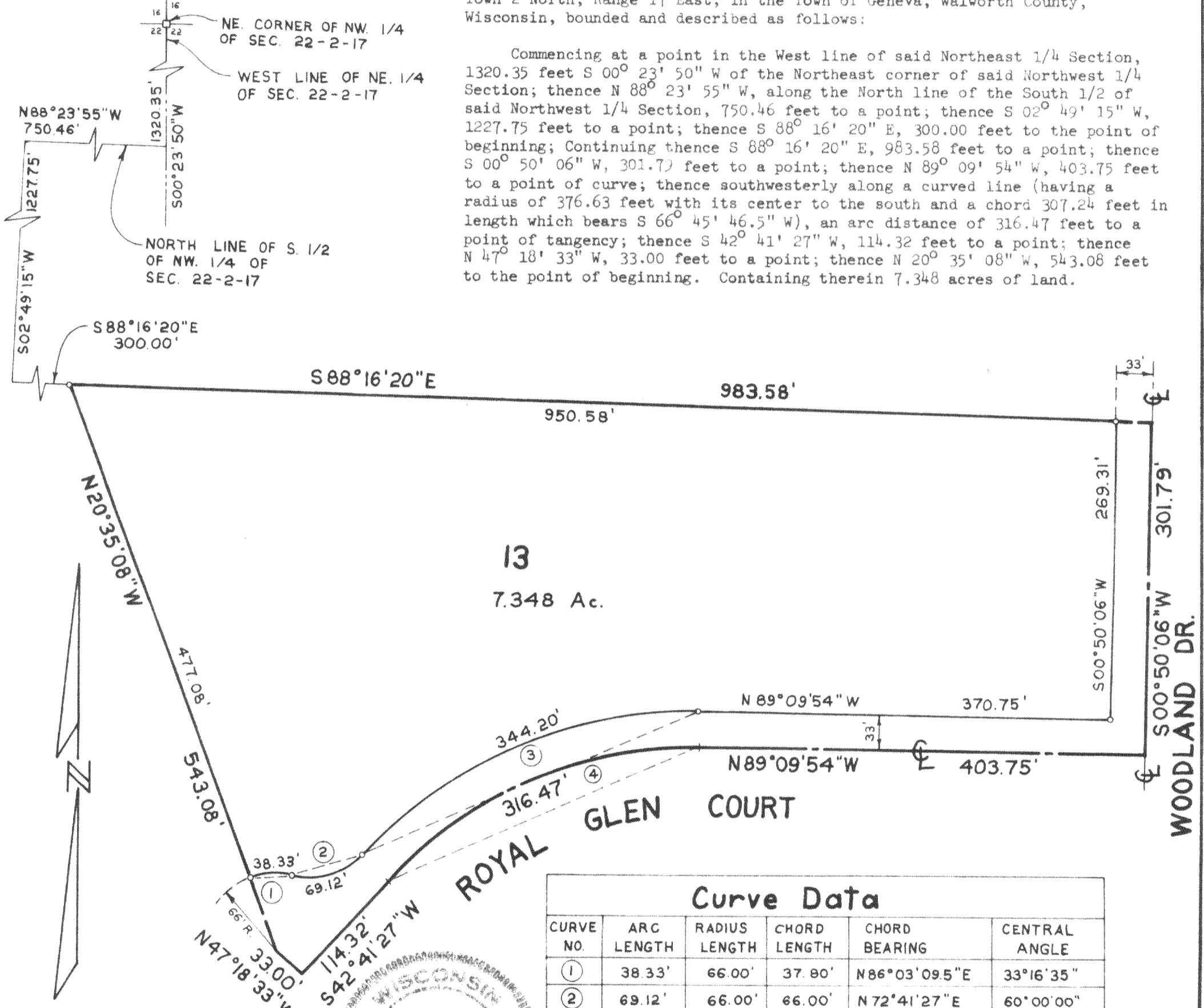

## PLAT OF SURVEY

DESCRIPTION: That part of the Northeast 1/4, the Northwest 1/4, the Southeast 1/4 and the Southwest 1/4 of Section 22, Town 2 North, Range 17 East, in the Town of Geneva, Walworth County, Wisconsin, bounded and described as follows:

Commencing at a point in the West line of said Northeast 1/4 Section, 1320.35 feet S 00° 23' 50" W of the Northeast corner of said Northwest 1/4 Section; thence N 88° 23' 55" W, along the North line of the South 1/2 of said Northwest 1/4 Section, 750.46 feet to a point; thence S 02° 49' 15" W, 1227.75 feet to a point; thence S 88° 16' 20" E, 300.00 feet to the point of beginning; Continuing thence S 88° 16' 20" E, 983.58 feet to a point; thence S 00° 50' 06" W, 301.77 feet to a point; thence N 89° 09' 54" W, 403.75 feet to a point of curve; thence southwesterly along a curved line (having a radius of 376.63 feet with its center to the south and a chord 307.24 feet in length which bears S 66° 45' 46.5" W), an arc distance of 316.47 feet to a point of tangency; thence S 42° 41' 27" W, 114.32 feet to a point; thence N 47° 18' 33" W, 33.00 feet to a point; thence N 20° 35' 08" W, 543.08 feet to the point of beginning. Containing therein 7.348 acres of land.
