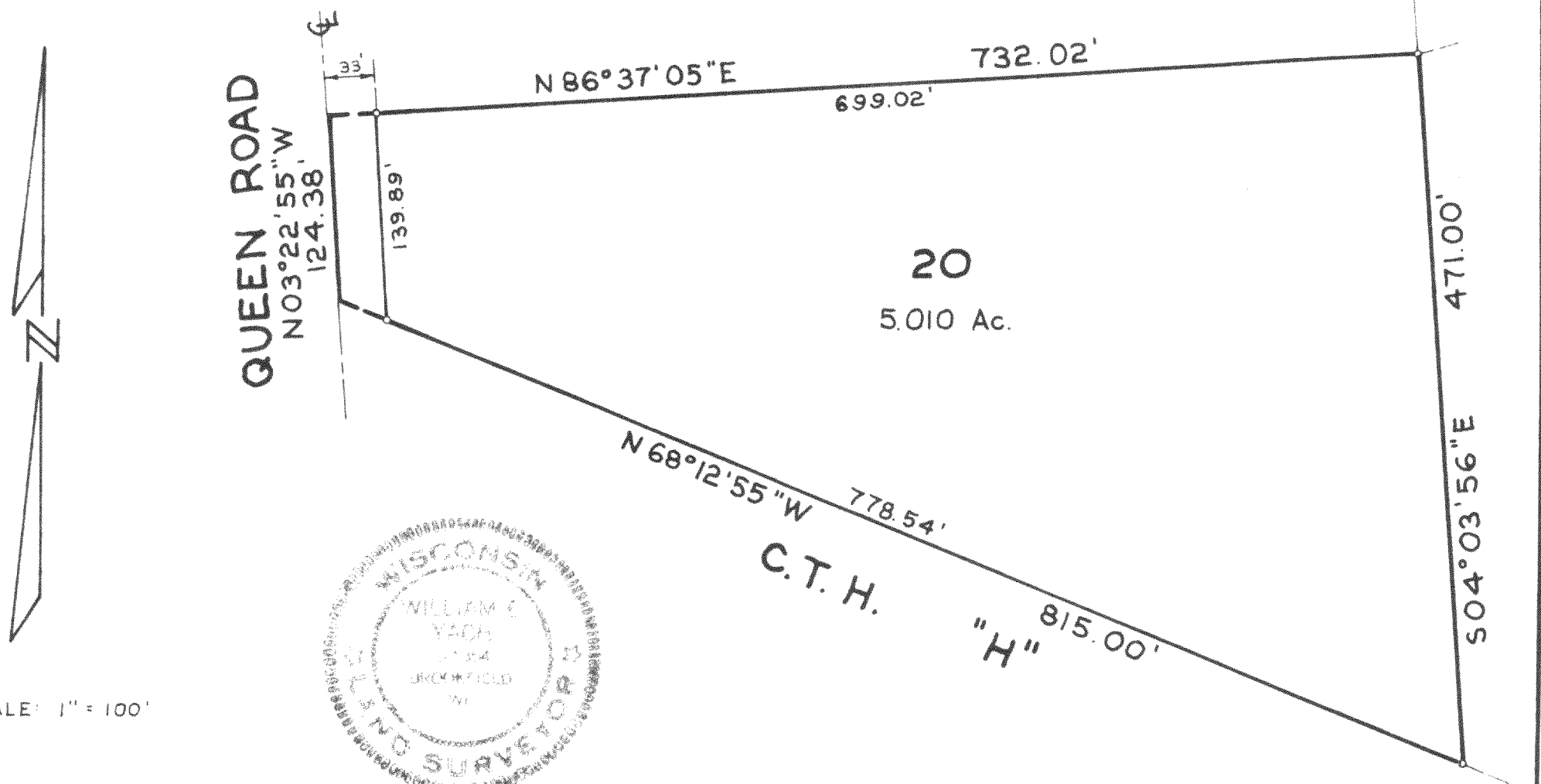

"H"; thence N 68° 12' 55" W, along the North line of C.T.H. "H"; 815.00 feet to a point in the centerline of Queen Road; thence N 03° 22' 55" W, along said centerline, 124.38 feet to a point; thence N 86° 37' 05" E, 732.02 feet to the point of beginning.
