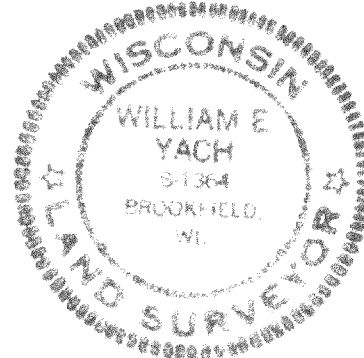
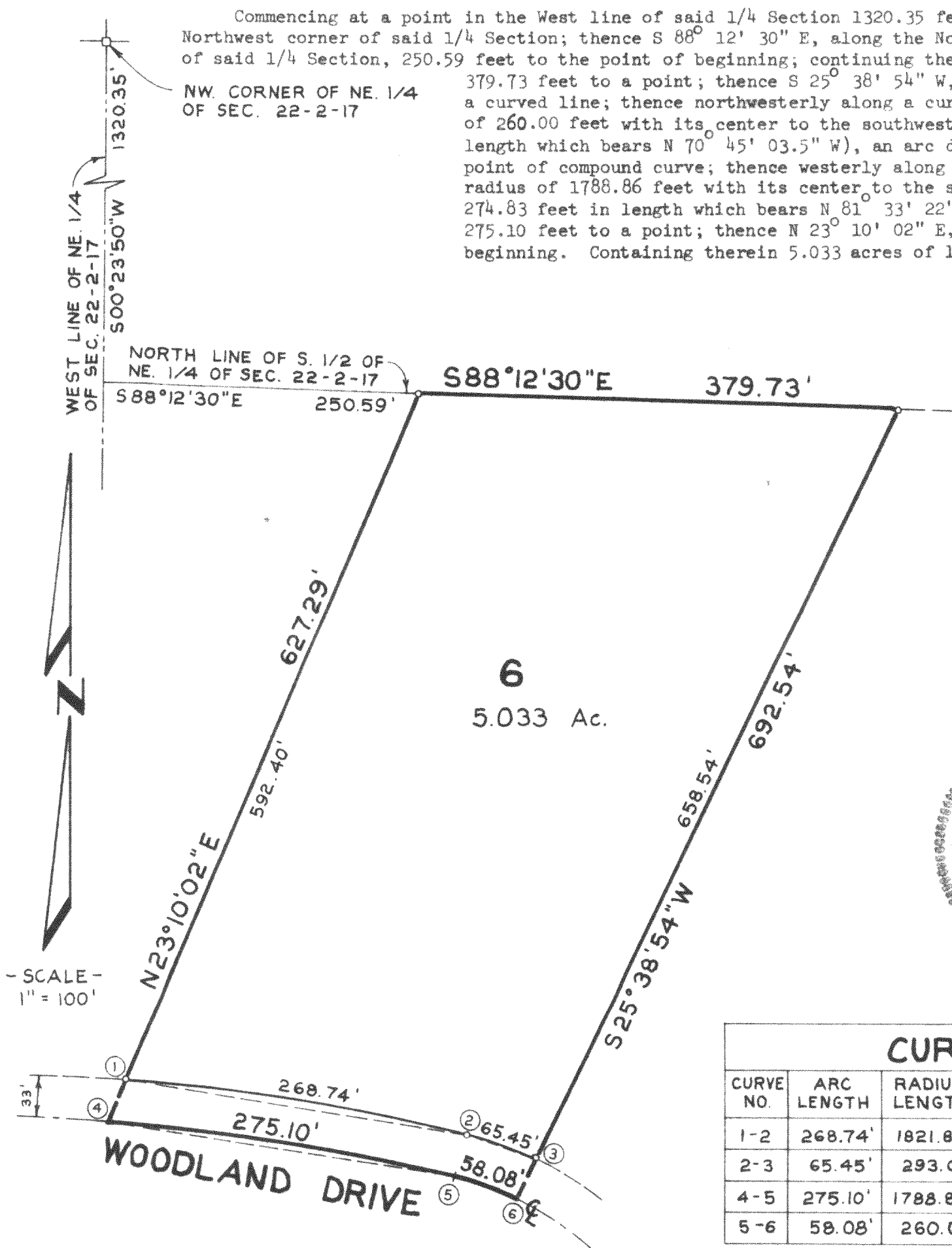

PREPARED FOR: Parcel 6 - ROYAL GLEN WOODLANDS

DESCRIPTION: That part of the Northeast 1/4 of Section 22, Town 2 North, Range 17 East, in the Town of Geneva, Walworth County, Wisconsin, bounded and described as follows:

Commencing at a point in the West line of said 1/4 Section 1320.35 feet S 00° 23' 50" W of the Northwest corner of said 1/4 Section; thence S 88° 12' 30" E, along the North line of the South 1/2 of said 1/4 Section, 250.59 feet to the point of beginning; continuing thence S 88° 12' 30" E, 379.73 feet to a point; thence S 25° 38' 54" W, 692.54 feet to a point in a curved line; thence northwesterly along a curved line (having a radius of 260.00 feet with its center to the southwest and a chord 57.96 feet in length which bears N 70° 45' 03.5" W), an arc distance of 58.08 feet to a point of compound curve; thence westerly along a curved line (having a radius of 1788.86 feet with its center to the southwest and a chord 274.83 feet in length which bears N 81° 33' 22" W), an arc distance of 275.10 feet to a point; thence N 23° 10' 02" E, 627.29 feet to the point of beginning. Containing therein 5.033 acres of land.
