

**PLAT OF SURVEY OF**

FIVE ACRES OF LAND ON THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 31, TOWNSHIP 2 NORTH OF RANGE 17 EAST, LYING NEXT NORTH AND ADJOINING THE LANDS OF MARTHA BURR AND EXTENDING IN EQUAL WIDTH ACROSS SAID WEST 1/2 FROM EAST TO WEST, ALL IN THE TOWN OF GENEVA. BURR, PLAINTIFF - vs EMMA L. WILLIAMS et al, DEFENDANTS AS THE SOUTH 16 ACRES OF THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 31, T2N,R17E. SAID JUDGMENT SO ENTERED WAS RECORDED JANUARY 19, 1894 IN VOLUME 87 OF DEEDS, WALWORTH COUNTY, RECORDS AT PAGE 520. EXCEPTING LAND CONVEYED FOR HIGHWAY PURPOSES AS RECORDED JANUARY 19, 1965 IN VOLUME 615 OF DEEDS, PAGE 321 AS DOCUMENT NUMBER 567112.

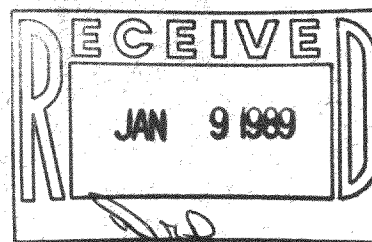
