

THE NORTHEAST CORNER OF LOT 23, BLOCK 2, OF BURKE AND CAMPBELL'S VILLAGE OF LYONS, ACCORDING TO THE RECORDED PLAT THEREOF IN WALWORTH COUNTY, WISCONSIN, AND MORE FULLY DESCRIBED AS FOLLOWS: BEGINNING AT AN IRON STAKE ON THE EASTERLY LINE OF SAID LOT 23, 12 FEET SOUTHERLY FROM THE NORTHEAST CORNER THEREOF, THENCE SOUTHERLY ON THE EASTERLY LINE OF SAID LOT 60.5 FEET TO AN IRON STAKE; THENCE WESTERLY 60 FEET TO AN IRON STAKE; THENCE NORTHWESTERLY 52.6 FEET TO AN IRON STAKE ON THE NORTHERLY LINE OF SAID LOT 4.9 FEET SOUTHWESTERLY OF THE SOUTHWEST CORNER OF LOT 18 OF SAID BLOCK; THENCE NORTHEASTERLY ALONG THE NORTHWESTERLY LINE OF SAID LOT 79.5 FEET TO THE PLACE OF BEGINNING. EXCEPTING THEREFROM THAT PART OR PARCEL OF LAND DEEDED TO FERDINAND ROBERS IN ONCE CERTAIN DEED DATED AUGUST 14, 1917, AND RECORDED DECEMBER 12, 1917, AT 1:00 P.M., IN VOLUME 151 OF DEEDS ON PAGE 276; AND SUBJECT TO THAT CERTAIN EASEMENT IN FAVOR OF THE WISCONSIN GAS AND ELECTRIC COMPANY, DATED NOVEMBER 22, 1915, AND RECORDED MAY 31, 1916, AT 8:00 A.M. IN VOLUME 147 OF DEEDS ON PAGE 21.
