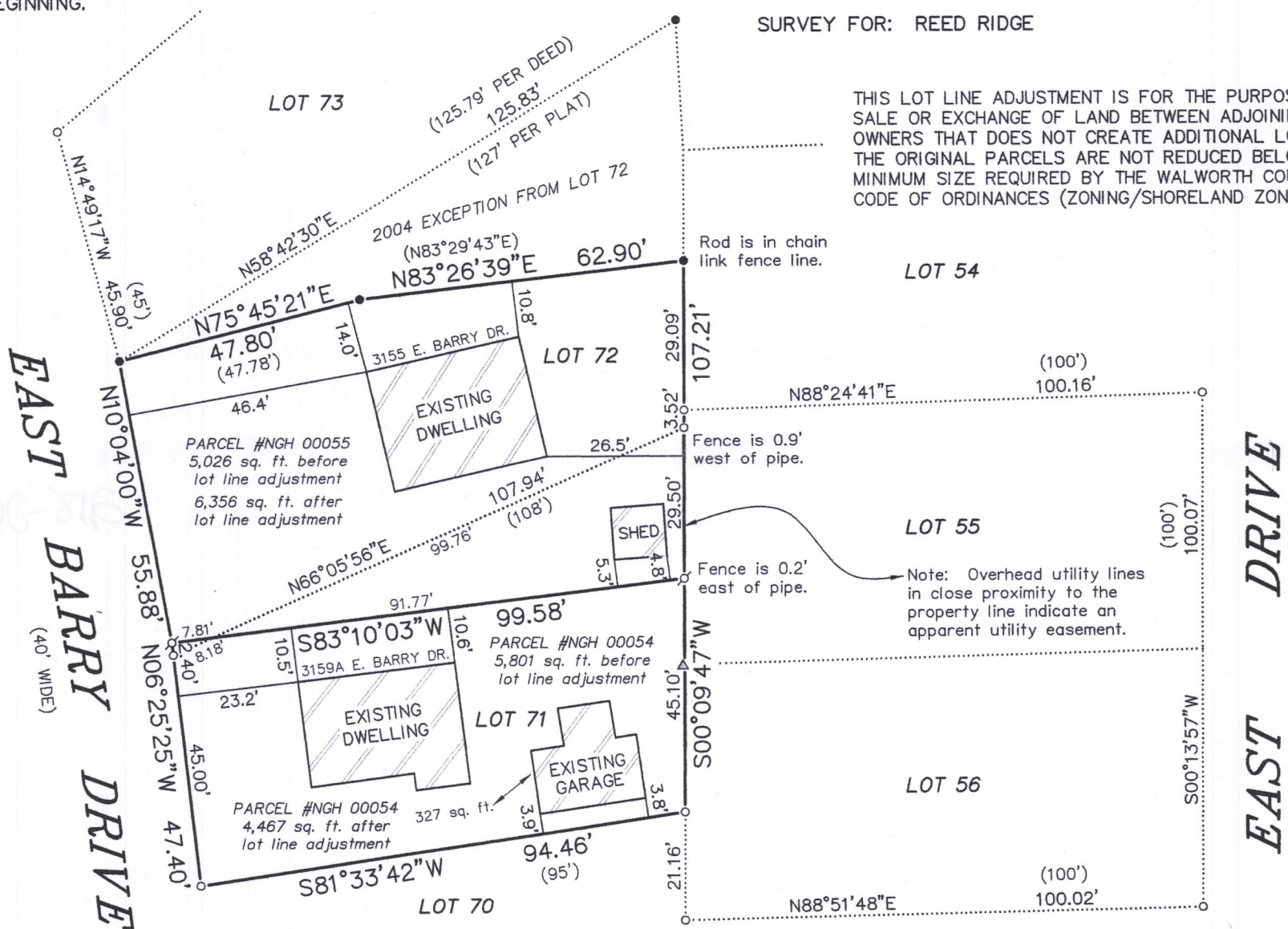

PART OF LOT 71 OF LAKE GENEVA GOLF HILLS, A SUBDIVISION LOCATED IN THE NORTHWEST 1/4 OF SECTION 31, TOWNSHIP 2 NORTH, RANGE 18 EAST OF THE FOURTH PRINCIPAL MERIDIAN, IN THE TOWN OF LYONS, COUNTY OF WALWORTH, STATE OF WISCONSIN, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT AN IRON PIPE MARKING THE NORTHWEST CORNER OF SAID LOT 71; THENCE NORTH 66°05'56" EAST, ALONG THE NORTHERLY LINE OF SAID LOT 71, 8.18 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE NORTH 66°05'56" EAST, ALONG SAID NORTHERLY LINE, 99.76 FEET TO THE NORTHEAST CORNER OF SAID LOT 71; THENCE SOUTH 00°09'47" WEST, ALONG THE EAST LINE OF SAID LOT 71, 29.50 FEET; THENCE SOUTH 83°10'03" WEST 91.77 FEET TO THE POINT OF BEGINNING.

AN ASSESSOR'S PLAT OF THIS SUBDIVISION SHOULD BE PREPARED TO ELIMINATE SAID AMBIGUITIES.

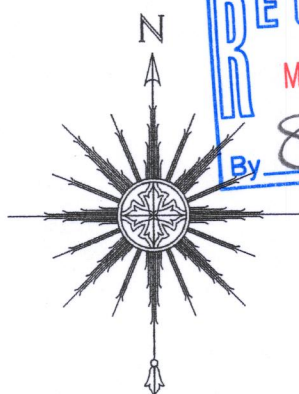

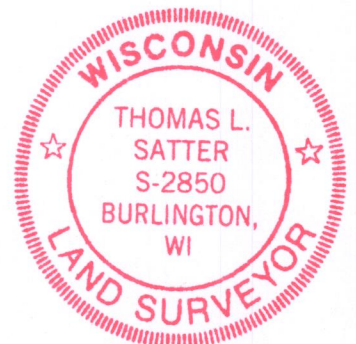
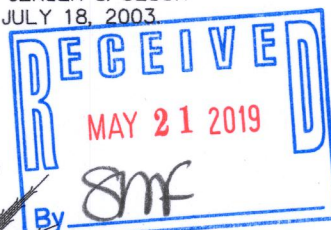
