

LEGAL DESCRIPTION OF EXISTING TAX PARCEL NLO-85B1

A parcel of land located in the Southwest 1/4 of Section 10 and Lot 7 on the west side of the White River in the Village of Lyons, all in T2N., R18E., Walworth County, Wisconsin, all of which is described as follows: Commencing at the Southwest corner of said Section 10; thence North along the west line of said section, 506.83 feet to the centerline of the public road; thence S87*19'E along said centerline 170.00 feet; thence N0*33'E (previously described as North) 150.28 feet to the place of beginning; thence continue N0*33'E 103.33 feet; thence N85*16'E 225.60 feet; thence S15*34'E 233.40 feet to the Southeast corner of said Lot 7 of the Village of Lyons; thence S68*30'W along the south line of said Lot 7, 68.20 feet; thence N87*19'W along the south line of said Lot 7; thence N15*30'W along the westerly line of said Lot 7, 132.00 feet; thence N87*19'W along the northerly line of Lots 8 and 9 in said Village of Lyons, 126.10 feet to the place of beginning.
