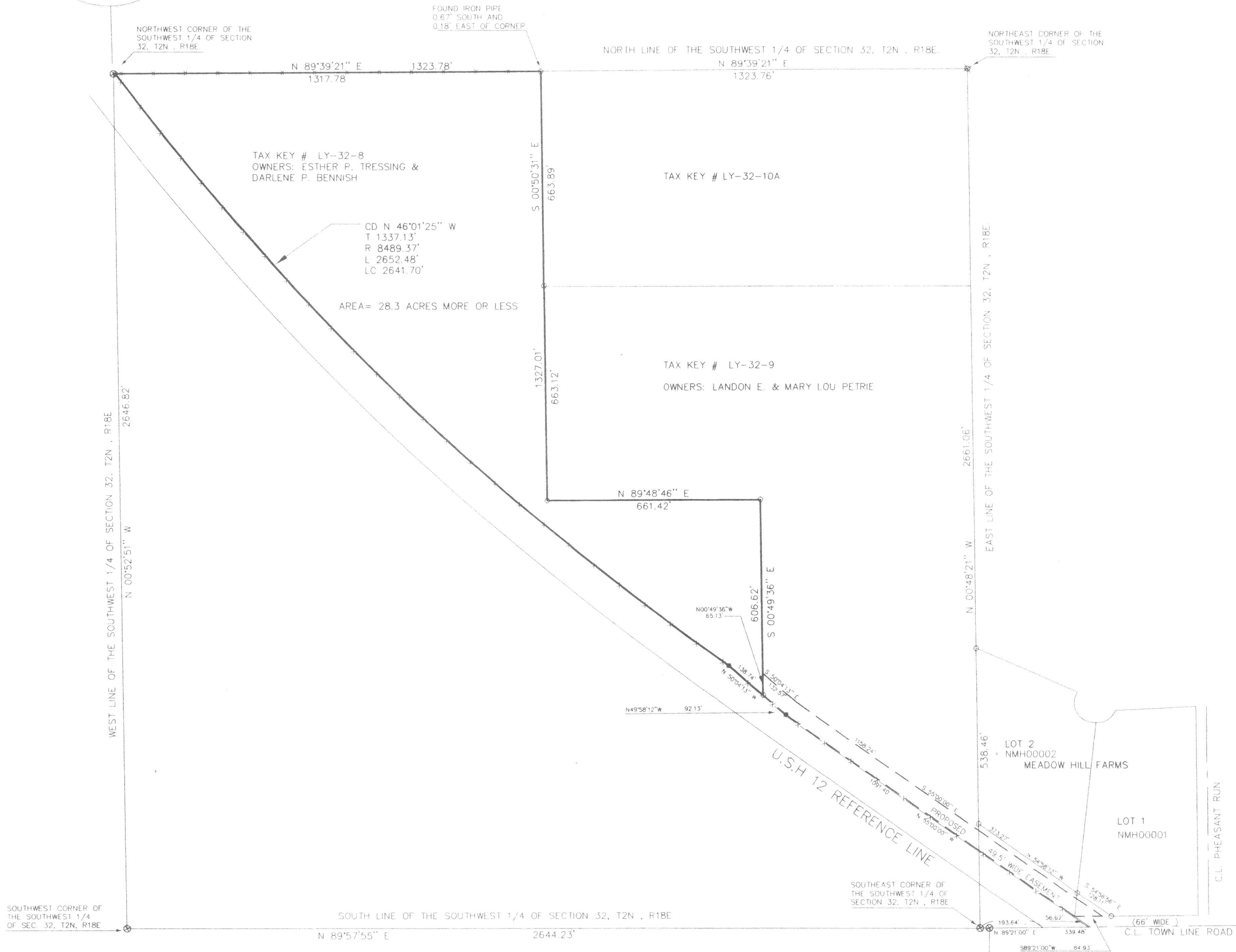
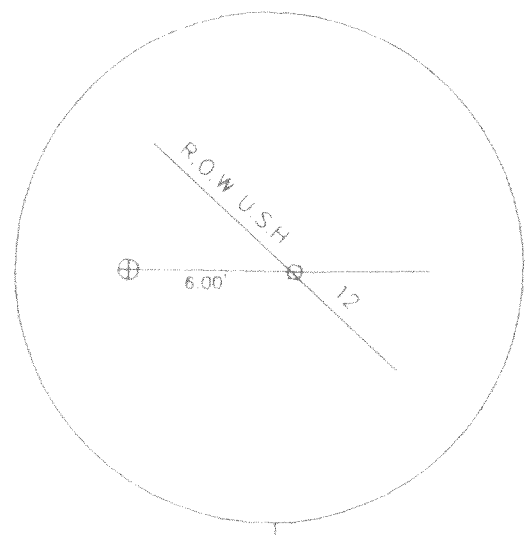


# PLAT OF SURVEY

DESCRIPTION: A PARCEL OF LAND LOCATED IN THE SOUTHWEST 1/4 OF SECTION 32, T.2N., R.18E., TOWN OF LYONS, WALWORTH COUNTY, WISCONSIN, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHWEST CORNER OF SAID SOUTHWEST 1/4; THENCE N89°39'21"E 6.00 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING N89°39'21"E 1317.78 FEET; THENCE S00°50'31"E 1327.01 FEET; THENCE N89°48'46"E 661.42 FEET; THENCE S00°49'36"E 606.62 FEET; THENCE N50°04'13"W 138.74 FEET; THENCE ALONG THE ARC OF A CURVE TO THE RIGHT WITH A RADIUS OF 8489.37 FEET AND WHOSE CHORD BEARS N46°01'25"W WITH A CHORD LENGTH OF 2641.70 FEET TO THE POINT OF BEGINNING.

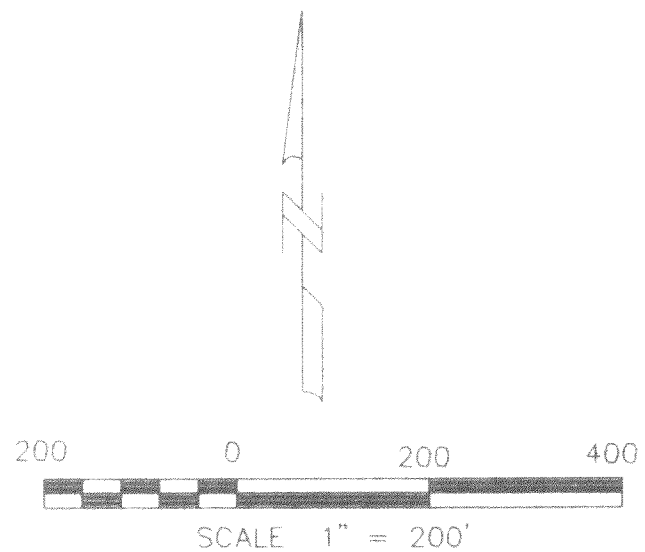
LEGAL DESCRIPTION PROPOSED 49.5 FOOT WIDE EASEMENT FOR INGRESS AND EGRESS

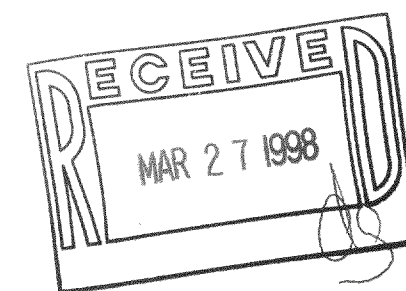
